

Writ challenges 100% quota for STs in scheduled areas

JUSTICE T Madhavi Devi of the Telangana High Court on Thursday directed the registry to place before the CJ bench the writ filed by a non-tribal welfare society challenging the Telangana Panchayat Raj

Act, reserving 100% seats to STs in scheduled areas in the ensuing local body elections. She adjudicated the writ filed by society secretary Konda-bathina Madhu of Ramnagar, Chunchupally mandal, Bhadradi Kothagudem district. The petitioner's counsel argued that due to allocation of 100% seats to STs in the

scheduled areas, even though there is no ST candidate available to contest the post of "sarpanch" in a particular gram panchayat in the scheduled area as a drawback, due to which the government is entrusting the work of sarpanches to special officers, instead of elected representatives. He sought a direction to the

government to permit a non-tribal to contest in such cases to ensure democratic governance at the grassroots level. The counsel urged the court to direct the government not to issue the election notification with regard to sarpanch posts in schedule areas reserving 100% to STs and stay the polls there.

has failed to pay heed, except for a few."

Interestingly, among those who have been repatriated to 'worthwhile' mandals, some are now unwilling to return to their original places, thus complicating the case for the majority who wish to return. For instance, one Tahsildar has applied for a key mandal like Bhadrachalam from a smaller mandal. Scores have opted for Khammam from neighbouring, less significant mandals. In southern Telangana, an official has applied for Nagarkurnool from a smaller mandal. "There could be around 40 to 50 who wish to stay back. The big mandals are much sought after. Those who were posted in Rangareddy and Medchal do not wish to yield," said an official posted within the city.

The official clarified that the government is not keen on transferring Tahsildars to native districts, with non-native districts subject to vacancy availability. Meanwhile, some officials who were astute enough to

TWO-thirds of the Mandal Revenue Officers (MROs), also known as Tahsildars, who were deployed to new districts during the Assembly polls in 2023, are still awaiting repatriation to their previous working districts. Out of more than 300 officials affected, fewer than a hundred have been transferred back to their original postings, with the remainder continuing to wait.

This marks the first instance in Telangana where these officials, who anticipated repatriation within months, have continued to serve in their newly allocated districts. "In the past, repatriation occurred not only in Telangana but also in the unified Andhra Pradesh within days of the polls," informed official sources. "Similar to the present state of Andhra Pradesh, during the YSR's time, all officials were repatriated in a single stroke of a pen. However, this time, despite most applying, the government

manage staying back and working in local collectorates during the elections have received 'rewarding' posts. "There is a feeling of injustice amongst those who left their places during polls. Some officials are enjoying at native places, while most are suffering in far-away places. The government is not ready to transfer at this juncture," added the official.

Disturbingly, some MROs have retired while still waiting for repatriation. One official, despite applying on health grounds, could not get approval from higher authorities. In an application to the CCLA (Chief Commissioner of Land Administration), the official, who was posted approximately 150 km from the State Capital and undergoing treatment at a corporate hospital following surgery, urged the Commissioner to be retained in the previously allotted district.

Warangal MLAs' clamour for action against Konda couple gets louder

Rival legislators accuse Endowments Minister and family of damaging party image

RIVAL legislators to Endowments Minister Konda Surekha from erstwhile Warangal have demanded action against her, accusing her and her family of damaging the party's image within the district. The MLAs, who are opposed to the Konda couple's alleged interference in their affairs, appeared before the party's disciplinary committee on Thursday.

During their meeting with MP and Disciplinary Action Committee chairman Mallu Ravi, they sought action against the Minister and Konda Murali, alleging their activities had tarnished the party's image in Warangal. In response to a summons, MLAs Kadiyam Srihari, Nayini Rajender Reddy, K R Nagaraju, Revuri Prakash Reddy, MLC BasavarajuSaraiah, and others appeared before the PCC's Disciplinary Committee at Gandhi Bhavan. The summons was issued following a complaint from former MLC Konda Murali, who alleged that the MLAs were engaging in anti-party activities and attempting to sideline him politically. Murali had previously submitted a detailed report to the committee outlining his version of events.

The disciplinary committee meeting, chaired by Mallu Ravi, involved a discussion of the ongoing feud between the Konda family and MLAs Kadiyam Srihari, Revuri Prakash Reddy, and others from Warangal. The committee is examining multiple dimensions of the dispute and will present its findings to the AICC State in-charge Meenakshi Natarajan and other senior party leaders. A final decision regarding the matter is expected after another meeting of the committee.

Last week, former MLC and Surekha's husband Konda Murali had submitted a 16-page report to the committee outlining his version of events. Over the past few weeks, several Warangal MLAs have accused the Konda family of making objectionable remarks and interfering in matters outside their constituency. The disgruntled leaders had earlier taken their grievance to Telangana Congress in-charge Meenakshi Natarajan and the TPCC Disciplinary Committee headed by Nagarkurnool MP Mallu Ravi.

2-day meet on adolescent health from tomorrow
