IISc quantum research park to lead India's tech drive: Min

BENGALURU: Minister for Science and Technology, N.S. Boseraju, has projected the Indian Institute of Science's (IISc) Quantum Research Park as a potential cornerstone of India's emerging quantum technology sector, with the state government committing 148 crore towards its development.

During a visit to the IISc campus in Bengaluru on Wednesday, Minister Boseraju engaged in extensive discussions with scientists and experts to chart a roadmap for quantum ecosystem development in the state and beyond. He emphasised the state government's resolve to position Karnataka as a frontrunner in quantum research and innovation.

"The Quantum Research Park at IISc has the potential to lead India's quantum mission. Under the leadership of Chief Minister Siddaramaiah and Deputy Chief Minister D.K. Shivakumar, Karnataka is fully committed to fostering a robust quantum technology ecosystem," the Minister said.

The 🛛 48 crore grant is being used to build stateof-the-art infrastructure, including cutting-edge laboratories, high-precision instrumentation, and incubation facilities for start-ups and innovators in the quantum domain. Boseraju assured that the state is ready to provide additional support as needed and would consult with the Chief Minister on further initiatives.

Professor Arindam Ghosh, head of the Quantum Research Park, noted that Bengaluru's vibrant academic, industrial, and R&D ecosystem makes it an ideal hub for quantum advancement. He advocated the formation of an international advisory committee to guide longterm strategic planning, with the goal of enabling a "Quantum Advantage Driven Economy" by 2035.

As part of its broader vision, the Karnataka government will host the country's first Quantum India Bengaluru Conference on July 31 and August 1, aiming to position the city as India's 'quantum capital.' The visit vas also attended by Raichur

Notices issued to CM's wife, top cops in MUDA case

IN a fresh twist to the controversial Mysore Urban Development Authority (MUDA) site allotment case, the Karnataka High Court has issued notices to Chief Minister Siddaramaiah's wife B.M. Parvathi, her brother B.M. Mallikarjunaswamy, the Director General of Police, and the Inspector of Vijayanagar Police Station in Mysuru.

A Division Bench comprising Acting Chief Justice V. Kameshwara Rao and Justice C.M. Joshi passed this order while hearing multiple appeals connected to the case. The original complaint was filed by social activist Snehamayi Krishna, who has sought a CBI probe into the alleged illegal allotment of 14 MUDA plots to CM Siddaramaiah's wife.

During the hearing, it came to light that notices had not been served to several key respondents, including Parvathi, her brother Mallikarjunaswamy, the DGP, and the Vijayanagar Inspector. The court has now ordered that notices and hand summons be served to all



ED raids Cong **MLA's properties**

Bengaluru: The Enforcement Directorate (ED) conducted raids on five locations in Bengaluru on Thursday morning, including properties belonging to Congress MLA Subba Reddy. The raids were carried out in connection with alleged violations of the Foreign Exchange Management Act (FEMA). Subba Reddy, who represents the Bagepalli constituency in Chikkaballapur district, has been under the ED's scanner over suspected foreign asset holdings and undisclosed international financial transactions. The searches targeted his residences and properties reportedly owned by his family and business associates. According to sources, the investigation focuses on bank accounts and real estate holdings in foreign countries including Malaysia, Hong Kong, and Germany. Officials arrived in five vehicles around 7 AM and began searching Subba Reddy's house near Marathahalli, Bengaluru, accompanied by a team of seven additional personnel.

The raids were still ongoing by afternoon, with ED officials examining bank documents and digital records from the MLA's home and offices.When questioned by the media, Karnataka Home Minister Dr. G. Parameshwara claimed he was unaware of the ED action against Subba Reddy.

ment activities of the Central Institute of Coir Technology (CICT) under the Coir Board in Bengaluru, according to an official release. Highlighting the growing potential of carbon extraction from coir fibre, Karandlaje expressed interest in its role in environmental sustainability and carbon credit markets.

She suggested that training programmes be modular and industry-specific-covering coconut-based products, carbon/charcoal extraction, and coir wood panel production. She also urged the CICT and Coir Board to actively collaborate with national-level technical institutions such as the Indian Council of Ag-



ricultural Research (ICAR), Central Plantation Crops Research Institute (CPCRI), Indian Institute of Horticultural Research (IIHR), the Coconut Development Board, and various state-level export units. The goal, she said, should be to create scalable and highvalue coir-based products.

Karandlaje reiterated that the technologies developed by the Coir Board must be systematically transferred to farmers, entrepreneurs, and cooperatives through a phased, sector-specific approach to ensure widespread adoption at the grassroots level, the release added.

Govt takes over historic Gali Anjaneya Swamy temple under Muzrai dept

THE historic Gali Anjaneya Swamy Temple located in Byatarayanapura on Mysuru Road, Bengaluru, has officially been brought under the jurisdiction of the Karnataka State Muzrai Department. The decision was taken following multiple allegations of financial mismanagement and administrative lapses within the temple trust.

A government order, issued under Sections 42 and 43 of the Karnataka Hindu Religious Institutions and Charitable Endowments Act, 1997, declares the temple a "notified institution." This follows a detailed report submitted by the Muzrai Department, which highlighted gross irregularities, including the alleged misuse of temple funds.

The controversy came to light last year when CCTV footage emerged showing trust members mishandling money while



counting offerings from the temple's donation box (hundi). The video, widely circulated on social media, triggered public outrage and raised questions about transparency in the temple's administration.

According to the Muzrai Department's report, the temple generates lakhs of rupees annually, yet the trust failed to maintain proper financial records for over 25 years. Records were reportedly created only after intervention by the department's assistant commissioner. It also stated that

despite the substantial income, there has been no surplus recorded, and the expenditure patterns raised suspicions of fund misuse.

The report further stated, "There is no internal harmony among the trust members, and management has been nontransparent. Given the misuse of funds, lack of accountability, and the public sentiment involved, the government deems it appropriate to bring the Gali Anjaneya Swamy Temple under direct Muzrai Department control for better regulation and to uphold devotees' faith."

The government order cited all these reasons and officially declared the temple a government-administered "notified institution" under the 1997 Act.

With this move, the administration of the temple is now under the Muzrai Department, ensuring better oversight, recordkeeping, and accountability, aiming to restore public trust in one of Bengaluru's most revered temples.
