

# Bhatti urges Singareni subsidiary APHMEI to boost competitive spirit

Deputy CM calls upon officials and staff to perform better in order to achieve greater profits and create more employment opportunities for youth

DEPUTY Chief Minister Bhatti Vikramarka Mallu said that APHMEI (Andhra Pradesh Heavy Machinery & Engineering Limited) should grow to a level where it can compete with the world. On Thursday, the deputy CM visited the Singareni subsidiary APHMEI located at Ibrahimpatnam, near Vijayawada in Andhra Pradesh, along with Singareni CMD Balram. On this occasion, he interacted with the workers and later spoke to the media.

Bhatti said that across the

globe, among engineering companies manufacturing spare parts for new industries and repairing and supplying old parts, none have better machinery or human resources than APHMEI. He assured that what the officers and workers of the company need is commitment, the mindset that "we can compete with the world," and the drive to effectively utilize the existing systems. If these are in place, he said, APHMEI too can compete globally.

He announced that a consultancy will soon be appointed to study the local conditions and submit a report on the com-

pany. Based on that report, the government will decide the direction in which to proceed. He emphasized that the better the officials and staff perform, the greater the profits will be, leading to more employment opportunities for local youth and contributing to the progress of the states.

The Deputy CM instructed that the plant and its machinery must be kept clean, the machines should be overhauled, and painted.

He also ordered that all working staff must strictly follow safety measures. He stressed that the industry can

progress only through the hard work and high aspirations of its workers.

He further said that this industry should not be limited to manufacturing new machinery and repairing old machinery for Singareni Collieries alone, but should also take orders required not only within the state but across the country, functioning like BHEL.

He said APHMEI manufactures and repairs machinery required for thermal power stations, and that the state government is considering how best to develop the company in the future.

## Police dept signs MoU with BRAOU to facilitate distance education for cops

Telangana Police is the first in the country to introduce such a measure, says DGP Dr Jitender

THE Telangana Police Department has entered into a Memorandum of Understanding (MoU) with Dr. B.R. Ambedkar Open University, Hyderabad, to enable non-graduate police personnel to complete their graduation. Director General of Police Dr. Jitender, stated that over 30,000 police personnel currently working in the department are non-graduates, and this initiative will give them the opportunity to become graduates within the next five to six years.

The DGP said that at present, the minimum educational qualification for recruitment as Police Constable is Intermediate, whereas earlier it was 10th Class. Personnel who joined the department in the past with the then-prescribed qualification will now have the opportunity to pursue and complete their graduation under this initiative.

Dr Jitender emphasized that higher education will boost the self-respect and confidence of the personnel, and expressed pride that Telangana Police is the first in the country to introduce such a measure.

University Vice-Chancellor Chakrapani appreciated the efforts of the DGP, noting that within a short period, he was able to make the MoU possible. He mentioned that the University has already started separate courses for the families of army personnel and now aims to extend similar opportunities to the families of police personnel.

Reiterating the University's slogan "Education at your doorstep," he assured that the institution will continue to uphold its mission.

Additional DGP (Training) V.V. Srinivas Rao informed that a variety of courses have been planned for police personnel and thanked the University for its cooperation in finalizing the MoU.

Additional DGP (Law and Order) Mahesh M. Bhagwat, in his vote of thanks, said the MoU was the brainchild of DGP Dr. Jitender and praised his vision for the welfare of the force.

Additional DGPs Anil Kumar, Charu Sinha, IGP's M Ramesh, Ramesh Naidu, Tafseer Iqbal, University registrar LVK Reddy and others participated in the MOU program.

Subjects may be covered in the Six-Semester Graduation Programme after discussions with concerned authorities. In the Semester 1 – Soft Skills, Semester 2 – Office Automation, Semester 3 – Public Administration and Office Administration, Semester 4 – Public Perception Management, Semester 5 – Police Skills, and Semester 6 – Life Skills.
