#### **SC** cracks down on stray dog menace

Summons top officials,

allows victims to testify NEW DELHI: In a major hearing on the nationwide stray dog menace, the Supreme Court has taken states and Union Territories to task for inaction, with Amicus Curiae Gaurav Agrawal assisting the court. The Apex court has summoned the Chief Secretaries of all states and Union Territories to answer 'why their compliances have not been filed'. In a significant move, the court has allowed dog bite victims to intervene in the Public Interest Litigation (PIL) without submitting the fees required from NGOs. The court is compiling comprehensive data from every state and UT on the number of stray dogs, dog bite cases, and the status of sterilisation and shelter homes. It has also indicated that it will pass directions regarding the feeding of dogs within institutional premises and will monitor the issue continuously, taking suggestions from all parties involved. A bench of justices Vikram Nath, Sandeep Mehta and NV Anjaria said, "We will be issuing directions with respect to government institutions and public sector undertakings where employees are feeding the dogs and supporting and encouraging stray dogs in the area." The court's remark was well-timed as Chief Secretaries of all states and Union Territo-

speeding after overtaking multiple vehicles before veering into the bus's lane, resulting in the ghastly impact. The drivers of both the vehicles, apart from 17 passengers, died on the spot.

The gravity of the collision was such that half the bus was filled with gravel, trapping passengers inside. The authorities deployed heavy earth-moving equipment to extricate passengers and clear the wreckage of the ill-fated bus. Eyewitnesses at the chaotic scene described passengers trapped amid loads of gravel, with screams filling the air as they struggled to get help.

The three sisters - Tanusha, Saipriya and Nandini - who were staying in Hvderabad, w ere among the 19 killed after the illfated bus collided with a gravel-laden tipper.

## nukes, claims Trump Justifies US' decision to resume N-tests



Washington

PAKISTAN is among the countries that are actively testing nuclear weapons, according to US President Donald Trump. The Republican leader's remarks came amid buzz of the US resuming the testing of its nuclear weapons.

Trump noted the move was necessary as several nations, including Russia, China, North Korea and Pakistan, are conducting nuclear tests, and it's also 'appropriate that the US also does it'.

"Russia's testing and China's testing, but they don't talk about it. We're an open society. We're different. We talk about it. We have to talk about it because otherwise you people are going to report. They don't have reporters that are going to be writing about it," Trump said while talking to CBS

News. "We're going to test because they test and others test. And certainly North Korea's been testing. Pakistan's been testing," he added.

Trump claimed the US does not "necessarily know" where these "powerful" nations that are testing nuclear weapons are but asserted the testing is being done. "They-- they test way under-- underground where people don't know exactly what's happening with the test. You feel a little bit of a vibration. They test and we don't test. We have to test," he said. Trump made these remarks when he was asked about his decision of "detonating nuclear weapons" after more than 30 years following Russia's recent trials of advanced nuclear-capable systems, including a Poseidon underwater drone.

# Mumbai Police arrest fake BARC scientist after 30 yrs

The conman made 40 international trips; received crores in foreign funds

THE Mumbai Crime Branch has arrested Akhtar Hussain Qutubuddin Ahmed (60), who allegedly posed as a scientist at the Bhabha Atomic Research Centre (BARC) for the past 30 years, leveraging this false identity to travel abroad and secure interna-

tional funding. Preliminary investigations reveal that Ahmed made 40 foreign trips, including visits to Iran, Saudi Arabia Russia, Thailand, and the United States.

Authorities discovered multiple bank accounts un-

#### der Ahmed and his brother

Adil Hussain, containing records of substantial international transactions. One key private bank account showed significant foreign deposits dating back to 2001.

Investigators estimate that since 1996, Ahmed had been receiving regular funding from countries including the US, Iran, and Iraq, though the exact sources of these funds remain unidentified.

During interrogation, Ahmed claimed to possess



sitive technical information, which he allegedly used to solicit foreign funds. The

police have seized the suspects' phones, laptops, and all fraudulent documents. Adil Hussain faces separate legal proceedings in Meerut, Uttar Pradesh.

Experts say the case highlights serious concerns regarding financial security and the misuse of international funding channels. By exploiting a fake scientific identity, Ahmed reportedly facilitated the structured inflow of foreign capital and maintained its circulation through banking networks.

Financial forensics are critical in such cases to determine whether these funds were diverted toward illicit

activities or the trading of sensitive technological information.

Security and policy concerns

Unauthorized access to sensitive scientific data and unmonitored international funding pathways could amplify threats related to terrorism or other unlawful activities. Security specialists emphasize that a combined cyber and financial intelligence approach is essential to prevent similar incidents in the future.

## State Alcobev industry pours out woes

#### Threaten to put brakes on booze supply

Hans News Service Hyderabad

LEADING industry associations representing the alcoholic beverages sector - the International Spirits and Wines Association of India (ISWAI), the Brewers Association of India (BAI), and the Confederation of Indian Alcoholic Beverage Companies (CIABC) - have collectively stated that the Alcobev sector in Telangana continues to reel under a tremendous financial crisis. This situation is attributed to the worsening payment backlog from the state government for liquor and beer supplies delivered to the state-owned whole-

saling corporation. The industry bodies have warned that this crisis can only be averted if the state government clears its old outstanding payments by November 10. Should the state fail to meet this deadline, the associations stated that the industry may not be able to fulfil supply demands in December 2025.

The associations highlighted a critical contradiction: while the sales of alcoholic beverages and corresponding revenue collections surged in October 2025, riding high on festive demand, the payments released to suppliers actually fell by almost 50 per cent compared to the preceding four months.

In October 2025, the heads of all three major industry associations repeatedly met senior government officials, including the Deputy Chief Minister and Excise Minister. They were reportedly given assurances that

the state would commence releasing payments and clear old outstandings on a priority basis, specifically those for the period May 2024 to August 2024, which have been outstanding for over a year. Despite these assurances, the associations jointly noted that there has been hardly any progress in settling the dues. The payment situation, they pointed out, turned for the worse in October 2025.

While Rs 484.58 crore was released until October 15, 2025 (including Rs 350 Crores for the May 1st to May 15th 2024 period), no payment has been released since then.

As a result, the total overdue outstanding amount now stands at a staggering Rs 3,366.21 Crores, which includes Rs 1,959.72 Crores pending specifically for the May to August 2024 period.

The industry reiterated that the failure to clear these old outstandings by November 10 could severely jeopardise the continuity of supply, potentially leading to shortages across the state during the critical month of December 2025.

# **CM Revanth fires SLBC failure salvo** on KCR; asks Harish not to talk crap

Hyderabad

STATING that the government is committed to complete the long pending world's biggest 40 km long SLBC Tunnel project works, Chief Minister A Revanth Reddy has announced that the government will provide compensation and address the grievances of the dwellers of the submerged Marlapadu, Keshya tanda and Nakkalagandi habitations located close to the SLBC project.

The project cost is estimated at Rs 4,600 crore and the government is ready to provide irrigation facilities to three lakh acres by lifting 30 TMC of water from Krishna River, the CM said Addressing the media af-

ter launching Aerial Electromagnetic Survey for the SLBC tunnel works at Mannevari Palli in Nagarkurnool district on Monday, the Chief Minister came down heavily on the previous BRS government for not completing the prestigious SLBC tunnel works during its 10 year rule for political reasons."

The SLBC project was sanctioned in 1983. The YS Rajasekhara Reddy government initiated the Tunnel-1 and Tunnel-2 works in the erstwhile united Andhra Pradesh in 2004 at a cost of Rs 1,968 crore. However, after K Chandrashekar Rao became Chief Minister in 2014, the works stalled. Slams KCR for decade-long delay



"KCR and Harish intentionally put the project on hold and created hurdles to prevent water supply to Nalgonda through gravity," the Chief Minister said, adding that such a massive tunnel project had not been undertaken anywhere else in the world.

CM Revanth Reddy noted that the project would have been completed at the cost of Rs 2000 crore had the KCR government completed the works. Today, the project cost was escalated to Rs 4,500 crore.

The CM took a broadside at KCR for not taking up even a single project on river Krishna and spent Rs 1.86 lakh crore on contractors in 10 years. Rs 1.05 lakh crore were spent alone on Kaleshwaram project, the Chief minister said that Irrigation Minister N Uttam

Kumar Reddy was making all out efforts to complete the SLBC works by roping in the Army officials to dig the tunnels without any trouble in the future. It was unfortunate that eight workers died during the excavation of the tunnel and the government supported the bereaved family members.

People dethroned the BRS government for not completing the SLBC project and now we are taking up the works on a war footing, the CM said that people will also not forgive us if the project is not completed.

The Chief Minister also criticised the previous BRS government for compromising on the utilisation of Krishna water. "The then Irrigation minister T Harish Rao signed an agree-

ment with Andhra Pradesh to utilise only 299 tmc of

The Congress government took serious note of it and made strong arguments before the Tribunal to protect the state interests ". The CM warned Harish Rao to stop making cheap comments and creating nonsense on water issues.

# Police foil SFI activists' bid to lay siege to ministers' houses

Even before the appalling memories over the recent bus blaze in Kurnool have could fade out, another ghastly road mishap in Chevella snuffed out 19 lives and injuring 22 passengers on Monday, sending shockwaves across Telangana. Driven by a speed demon, the gravel-laden tipper was said to be on the wrong side, leading to the grisly accident.

# Chevella banyans battle: Heritage vs highway makes NH 163 a 'deadly' corridor

Conservationists clash with NHAI over plans to fell 900 Nizam-era trees for road expansion, citing accident risks

Hyderabad

FOR nearly a century, the majestic banyan trees lining the Chevella-Moinabad stretch of National Highway 163 (NH 163) have stood as a living heritage of Telangana's past, with their origins dating back to the Nizam era. These almost 900 ancient trees, along with thousands of others, provide a unique ecosystem and a remarkable canopy that travellers have marvelled at for generations.

However, since 2019, this green legacy has become the epicentre of a fierce environmental battle. Citizen-led groups, notably 'Save Banyans of Chevella' and 'Nature Lovers of Hyderabad (NLH), have been championing the cause to protect these irreplaceable trees against the National Highways Authority of India's



(NHAI) plans to expand the highway from two to four

These groups have mounted persistent protests, filed petitions with the National Green Tribunal (NGT), and meticulously geotagged the banyans to counter government claims and demand comprehensive ecological considerations within the

expansion plans. During the previous BRS government's tenure, the land acquisition for the NH 163 widening project saw significant delays. Disputes over compensation, protracted court cases, and environmental litigations fuelled by activism culminated in multiple NGT orders halting construction to ensure thorough Environmental Impact Assessments

The NGT formally recognised the ecological importance of the banyans, particularly their biodiversity support, and mandated revised assessments to minimise environmental damage. Despite these clear directives, stalled land acquisitions and political hesitance have perpetuated dangerous bottlenecks on this already perilous highway.

Activists contend that the government prioritised avoiding conflict over proactive dialogue, which effectively prolonged the highway's hazardous state and led to numerous fatal accidents.

The 'Save Banyans of Chevella' group employed a scientific approach to data collection and advocacy, exposing gaps in the NHAI's

mitigation claims. They have demanded genuine measures, such as reliable tree translocation with survival guarantees and road realignment where feasible.

This critical stretch be-Moinabad and Manneguda, which links Hyderabad and Bijapur, remains a stark reminder of the clash between heritage conservation and infrastructure needs. While the ancient banyan trees are spared for the moment, the highway continues to bear the burden of delayed development and recurring

As the NH 163 expansion resumes under government mandates, the hope remains for balanced progress that preserves these ecological treasures while simultaneously ensuring safer passage for the thousands who travel this vital route daily.

# Experts warn overloaded buses: heavy vehicles fuel road tragedies in TG

Hyderabad

FOLLOWING heavy vehicle accidents, the road safety experts have stressed a combination of safety measures focused on controlling overloading of carriers or overcrowding of buses, over-speeding and vehicle condition. The experts urged the State Transport Department to be proactive in their enforcement efforts.

In the last 10 days, the state witnessed two major road accidents with nearly 40 deaths of the people in two Telugu states. On October 24, a private bus going to Bengaluru from Hyderabad burst into flames in Kurnool district after colliding with a bike, killing 19 people.

On Monday, 19 persons lost their lives when an RTC bus from Tandur to Hyderabad was crushed under a gravel-laden tipper truck near Mirzaguda in Chevella in Ranga Reddy district.

The experts highlighted that the preliminary police investigations revealed that both vehicles were carrying excess load. The truck was overloaded with gravel, while the RTC bus had far more passengers than its permitted capacity.

Opinions are that an overloaded truck and an overcrowded bus were a deadly combination, regardless of who was at fault. Poor road conditions and failure to deploy enough buses to handle passenger rush were also being cited as major causes.

The experts said that the Mahalakshmi scheme has caused overcrowding on TGSRTC buses by significantly increasing commute, especially among women. Earlier, the state-run

buses used to transport over 50 lakh passengers in the state but now following the scheme it has crossed 66 lakh passengers, with the same fleet of buses.

"In the tragic accident that occurred in Chevella on Monday, 14 female and five male passengers lost

their lives. The incident was caused by overcrowding, which also underscores the need for adequate bus services under the existing state transport schemes," said R. Nageshwar, a road safety expert.

It has been witnessed that the buses are running overcrowded across the state. The buses are accommodating more passengers than the capacity. The bus which collided with the tipper was accommodating more than 70 passengers.

Mohammed Asif Hussain, another expert highlighted that the RTA officers must act on the RTC buses for overcrowding. When overloaded, the vehicle becomes unbalanced, which can result in accidents. Citing the example of the

inspection by the Jagtial district transport officials in July last year, Asif Hussain said, "The Jagtial transport officials seized the state-run bus for carrying 112 passengers, which was supposed to carry 55 passengers. Since then, there were no reports of the RTA inspecting RTC buses," said Asif Hussain.

Sri Harsha, a member of the Road Squad Team dedicated to promoting road said that the overloading of buses is a serious concern. It can only be controlled when both the government and the public understand the risks involved. The long-term solution lies in increasing the number and frequency of buses so that passengers are not forced to travel unsafely.

Furthermore, the Tipper lorries are often used for shuttle services repeatedly travelling on the same stretches of roads. This familiarity tends to create overconfidence among drivers, leading to over speeding and careless driving, pointed out Harsha.

He said that a major reason behind the frequent heavy vehicle accidents is the lack of proper driver training. In many cases, cleaners gradually become drivers without undergoing any structured training. This poses serious risks on high-

"In Telangana, there are only a few Institutes of Driver Training and Research such as those in Karimnagar, Sangareddy. For RTC drivers Warangal and Hyderabad training institutes are available, which are insufficient to meet the state's growing demand.

The government should encourage and support private sector participation in establishing more highquality driver training institutes across all districts," said Harsha.

The member of the Road Squad Team said that strict enforcement is equally important. Installation of dashcams in all heavy vehicles and periodic monitor. ing by independent audit teams can greatly enhance accountability and road safety standards.

The road safety experts urged the authorities to fill potholes and resurface damaged patches, install lane reflectors, signage, and rumble strips, enforce speed limits and driver rest regulations and deploy night highway patrols.

## Post-mortem done, bodies handed over to kin; 22 injured get treatment

THE injured passengers in the RTC bus and tipper collision were treated at Chevella and nearby hospitals, while the post-mortem examinations of the deceased were conducted by a team of doctors from Gandhi and Osmania Hospitals. The bodies were handed over to their families by 3

According to officials, 19 passengers died in the accident, including 13 women, five men, and a two-monthold infant. As many as 19 passengers are undergoing treatment at various hospitals — 14 at Patnam Hospital, three at the CHC in Chevella, and two at Lalitha Hospital in Chevella. The condition of 18 passengers is said to be stable. Doctors stated that one patient with a head injury is under treatment but is now out of

After learning about the accident, the Health Minister C Damodar Raja Narsimha directed the higher officials to rush to the accident site and supervise the treatment and complete other formalities.

He had directed the Health and Family Welfare Commissioner Sangeetha, State Medical Education Director Dr Narendra Kumar and Vaidya Vidhana Parishad Commissioner Dr Ajay Kumar to form a team of doctors to provide better treatment to the victims.

The minister directed the officials over the phone to appoint a committee of doctors to provide better treatment to the injured. The minister later visited the hospital and interacted with the injured. The minister consoled the injured, assuring that the government would oversee their treatment. He also enquired about the incident from the bus conductor.

## TGSRTC announces ₹2 lakh exgratia sum after fatal crash

**Corporation confirms insurance aid for victims; preliminary** report clears bus driver, blames speeding tipper lorry

THE TGSRTChas announced an ex-gratia payment of Rs 2 lakh each to the victims of the recent fatal road accident in Chevella, in addition to providing the insurance amount through the Vehicle Insurance Policy.

Y Nagi Reddy, the TG-SRTC Vice Chairman and Managing Director, visited the accident site, personally monitored the rescue operations, offered his condolences to the bereaved families, and instructed officials to provide comprehensive

support. According to a preliminary inquiry conducted by the TGSRTC, there was no fault found with either the condition of the TGSRTC bus or the driving of the bus operator. The bus was confirmed to possess all necessary Fitness and valid Insurance certifications. The corporation stated that the accident was caused by the over-speeding of a heavily loaded gravel tipper lorry, which overturned and fell onto the bus after the tipper driver lost control of the vehicle in what is known to be an accident-prone spot.

The crash occurred around 6:15 am near Indira Reddy Nagar, Mirzaguda (within Chevella limits). The bus, registered TS34TA 6354 (Tandur), was struck head-on by the tipper lorry, registered TG06T 3879, which was travelling in the opposite direction at high speed.

A senior TGSRTC officer explained that the tipper, which was loaded with gravel and hard stone chips from Lakdaram (Patancheru, Sangareddy District) and en route to Manneguda, lost control while attempting to overtake multiple vehicles. It subsequently veered directly into the path of the oncoming bus. The

resulting impact caused extensive damage to the bus, with a large volume of gravel and dust pouring into the passenger compartment. This debris led to passengers being trapped, resulting in severe breathing difficulties, multiple injuries, and fatalities due to a combination of

suffocation and trauma. Senior TGSRTC officials, including the Executive Director (O&IT) ED/HZ, JD(V&S), RM/ RR, Dy.RM(O)/RR, and Dv.RM(M)/RR, rushed to the location to oversee operations and review the circumstances of the crash.

Swift rescue and relief operations were coordinated by senior Police Officers, Emergency Services personnel, the District Collector, and Revenue Department officials. TGSRTC Depot Managers from Tandur, Parigi, and Vikarabad coordinated the on-ground response and the transfer of the injured to hospitals.

# Give an action plan for Manipur's development: Bandi Sanjay

UNION Minister of State for Home Affairs Bandi Sanjay Kumar has called for a comprehensive action plan to accelerate Manipur's development, urging the state government to submit short-term, medium-term, and long-term proposals within a week. ### TG Colleges shut down over ₹5,000 cr fee reimbursement dues

A sweeping disruption unfolded across Telangana's academic landscape on Monday as numerous private colleges and higher education institutions suspended operations. This was in response to a coordinated, indefinite strike led by the Federation of Associations of Telangana Higher Institutions (FATHI), aimed at drawing attention to the state government's longpending financial commitments.

Outside campuses, handwritten notices and banners signalled the closure, while students, faculty, and staff staged demonstrations across districts. various protests, which included sit-ins and symbolic blockades, received backing from student unions and civil society groups, amplifying the collective demand for fiscal account-

ability. Institutions offering professional courses, including engineering, pharmacy, business administration, education, and nursing, were among those participating. Organisers allege that the government had previously pledged to release substantial funds to cover tuition reimbursements but failed to fulfil the commitment in full. While an initial tranche was disbursed, the remaining amountwhich

The ongoing impasse has raised serious concerns among students and parents, particularly those preparing for examinations or awaiting place-

As the strike gains momentum, all eyes are on the government's response. Whether it will engage with the protesting institutions or propose an interim solution remains to be seen. For now, the corridors of learning across Telangana fell silent on Monday.

FATHI leaders also expressed gratitude for the widespread support of the strike. Ramdas thanked students, parents, and the general public for their overwhelming backing of the bandh. He stated, "We thank everyone who stood with us today. The complete shutdown across Telangana reflects the seriousness of the issue and the unity of the education community." The leaders emphasised that the delay in scholarship payments has severely impacted colleges' ability to function, pay staff, and support students, urging the government to act swiftly to prevent long-term damage to the higher education

A Yellow alert warning has also been issued, predicting that thunderstorms accompanied by lightning and gusty winds (30-40 kmph) are very likely to occur at isolated places in the districts of Adilabad, Nirmal, Nizamabad, Jagityal, Yadadri Bhuvanagiri, Rangareddy, Hyderabad, Medchal Malkajgiri, Vikarabad, Sangareddy, Medak, Kamareddy, Mahabubnagar, Nagarkurnool, Wanaparthy, Naray-

anpet, and Jogulamba Gadwal. Similarly, for Wednesday, IMD officials have forecast light to moderate rain or thundershowers likely to occur at a few places over Telangana. A warning for thunderstorms accompanied by lightning and gusty winds (30-40 kmph) remains in effect for isolated places in Adilabad, Komaram Bheem Asifabad, Nirmal, Nizamabad, Jangaon, Siddipet, Yadadri Bhuvanagiri, Rangareddy, Hyderabad, Medchal Malkajgiri, Vikarabad, Sangareddy, Medak, Kamareddy, Mahabubnagar, Nagarkurnool, Wanaparthy, Narayanpet, and Jogulamba Gadwal districts.

The IMD officials have issued a forecast of light to moderate rain or thundershowers very likely to occur at isolated places over Telangana until November 6, with dry weather expected to set in from November 7.

According to the officials, the winds are currently blowing north-westwards in the lower troposphere over Andhra Pradesh and Yanam. Furthermore, a surface cyclonic circulation formed over Vidarbha and its adjoining Marathwada region at an altitude of 0.9 km above mean sea level on Monday. Officials have stated that, due to this meteorological system, light to moderate rains are likely to occur in the Telugu states for the next three days.

# Kishan Reddy blasts 'BRS-Congress- BJP is king in Jubilee Hills, Majlis trio', calls for JH reclamation

Union Minister urges voters to back BJP's Deepak Reddy, accusing rivals of decades of neglect and empty promises

UNION Minister G Kishan Reddy, as part of the ongoing electioneering for the Jubilee Hills by-poll, launched a spirited campaign with a bike rally on Monday. The rally commenced at Nagarjuna Community Hall in Srinagar Colony and concluded at Poorna Tiffin Center, passing through key localities including Yellareddy Guda, New Science Colony, RBI Quarters, Yusuf Guda Basti, Ganapathi Complex, IN Community Line, and Venkatagiri Ganesh Temple. The event drew enthusiastic support from BJP cadres and local residents.

Addressing the rally, Kishan Reddy appealed to voters to strengthen Prime Minister Narendra Modi's leadership by ensuring the election of BJP candidate Deepak Reddy with a resounding majority on November 11. He heavily criticised the BRS and Congress parties for decades of neglect in Jubilee Hills, citing overflowing drainages, unlit streets, and poor drink-





ing water facilities as visible signs of their failure.

"Let KCR walk through Jubilee Hills and see the development he claims," Reddy challenged, adding

tacks on Hindu households by the Majlis party, Reddy urged voters to reject divisive politics and instead support the BJP's developmentfocused agenda. He declared, "Let us teach these parties a lesson with our votes and pave the way for a new Jubilee Hills."

UNION Minister G Kishan Reddy asserted the BJP's dominance in the Jubilee Hills by-election campaign on Monday, strongly criticising the Congress, BRS, and Majlis as "opportunists."

ranks and sympathisers are supporting the BJP. This is a three-way contest, and we're ready," he said. He further clarified that the BJP did not delay candidate announcements, having declared seven by-election nominees simultaneously. Taking aim at former cricketer and Congress leader Mohammad Azharuddin, Reddy alleged that his ministerial post was granted solely to attract Muslim votes. "If Azharuddin could win the election in Jubilee Hills, he would've been given a ticket. But he carries many allegations, and even his af-

Regarding infrastructure, Reddy revealed that L&T had written to the Centre expressing its inability to manage the Hyderabad Metro due to a lack of clarity from the state government. "What should our minister do when the state has no plan?" he asked. He also criticised the state government's failure to meet with the Prime Minister and Home Minister regarding key state issues.

Addressing Backward Classes (BC) welfare, Reddy reiterated the BJP's commitment to justice for BC communities. "We made a BC the Prime Minister. We're conducting caste enumeration nationwide and will convince the courts," he said. He then challenged the Chief Minister to prevent the Mailis from contesting all BC seats in local body elections, pointedly asking, "Does he have the

Don't be afraid of anyone, ensure the victory of BRS," K T Rama Rao declared

The BRS leader recalled that the Congress had promised to give Rythu Bharosa to tenant farmers but were now claiming they had no money. the state found money to send to the party's high command, stating: "You are sending hundreds of crores to Rahul Gandhi in Delhi every month but there is nothing to give to the poor in the gali".

# The new criminal law is compelling disclosure of sources

ll rules under the Data Act (DPDPA), including questions, apprehensions and queries revolving around pre-censorship that curbs freedom of press are taking one back in time to the dark days of Emergency. As things stand, the Centre, the ministry, its officers and staff pose a threat to Article 19(1)(a) in particular, and to the Constitution of India, in general.

#### New pre-censorship: Blocking news site

A journalist body rights contends "Repeated noncompliance can ultimately attract blocking under the IT Act, read with Section 37 DPDPA (blocking for dataprotection reasons). Will MEITY commit to seeking prior judicial authorisation before any news site is disabled?

journalists Secondly, can forget public interest reporting and kill small newsrooms. What is the quantifiable threshold of non-compliances before action is initiated? When deciding penalties, Section 33 directs the Board to consider factors such as the "nature, gravity and duration" of the breach. Given that honest publicinterest reporting may involve leaked data, how will proportionality be guaranteed so fines do not have a chilling effect on smaller newsrooms and individuals engaged in journalistic ac-

Third points to killing journalism through two enactments: MEITY obtaining DPDPA's consent and meeting requirements with statutory privileges under the Press and Registration of Periodicals Act and the Working Journalists (Conditions of Service) Act remain a source for debate.

The fourth point is about getting attacked in the name of the Information Technology Act. Given that the Central Government has been empowered to block information/content under Section 69A of the IT Act, what is the purpose behind including Section 37(1)(b) that creates another parallel blocking regime that further empowers the Central Government to issue blocking directions under the DP-DPA framework?

#### Scribes cannot pay heavy penalty:

Every rule is dangerous due to the penalty clause. The society should realise that a real threat is from the proposed penalty clause of Rs 250 crore, which can go up to Rs 500 crore against an individual or entity if the DPDP Board appointed by the government deems fit. This effectively can close the gates of information, journalism and freedom of speech and expression. In short, it will kill a significant part of the Constitution.

#### Child 'Data Act':

There is a 'child data' law, though adults suffer. Implementation of the 'child data' law can be draconian. Generally, rules under a statute (an Act) should not create substantive legal problems. They are expected to help ease the difficulties in understanding and implemen-

tation of the law.

But then, Draft Rule 10(1) forces outlets to obtain ageverified parental consent before processing a child's data. How should people involved in journalistic activity or media organisations cover issues affecting minors in real-time without breaching this rule?

#### **Revealing sources:**

Media has always debated about protecting resources of reporting. It is not just an ethical question but a serious criminal point. The flashpoint is in 'revealing sources' and it gives sweeping powers to the Union Government. Journalist bodies and activists fear that clauses granting the government broad powers could be misused to unmask confidential sources. Besides precensorship, together with 'compelling the resource of reporting the news' will be more draconian than the '1975 Emergency' phase.

Since ages 'revealing sources' were protected as ethical and legal principles in democracies. Exceptions can only be in some compelling legal situations. Journalists' sources are revealed when their identities are exposed, either through their own voluntary disclosure or by being forced by legal authorities, which can happen in court if the information pertains to a crime or other legal proceedings. Sources are revealed when legal protections are absent, or when a iournalist cannot or will not use legal or technological methods to keep them anonymous. Source protection is vital, as without it, people would be deterred from sharing public interest information with journal-

(IWPC) have raised worries over the consequences of the Digital Personal Data Privacy (DPDP) Act. 2023, and the rules thereof. The Ministry of Electronics and Information Technology (MeiTy) is yet to reply to media representations and the serious apprehensions. This is how threats to journalism emanate from the Data Act. The press bodies' pointed out: Clause (c) of sub-section (7) under Section 28 and Section 36 give the Data Protection Board and the Central Government sweeping powers to call for "any data, book, document, register, and book of account or any

other document." Now, investigative journalism largely relies on "source-based information" or leads provided by whistleblowers. Given the wide range of powers have been vested in the Data Protection Board, it can very well demand a person involved in journalistic activity or media organisation to reveal the "source".

In that case, what are the protections available to a person involved in journalistic activity and media organisations from revealing a "source" under the Act?

#### No editorial independence?

Draft Rule 6(g) demands "appropriate technical and organisational measures to ensure effective observance of security safeguards" and can be enforced by the Board. What limits will be set so that inspections do not morph into newsroom searches, jeopardising editorial independence remains unknown?

#### Whistle-blower and a bleak future!

Draft Rule 7 obliges a data fiduciary to alert every affected person after a leak. If a whistle-blower leaks wrongdoing inside a company, PSU, government department, etc., must the person involved in journalistic activity or the notify the very officials under investigation, thereby exposing its source?

"This indirectly earns brownie points for Kharge Senior with the Nehru-Gandhi family and helps him survive in Delhi. Kharge Junior has become a kind of guru to the Siddaramaiah government on ideological matters," he alleged.

# Air pollution: Cloud seeding is not the solution

Cloud seeding can interfere with naturally occurring rainfall.

**TLOUD** seeding is the process of artificially inducing rainfall. To provide relief from air pollution in Delhi after Diwali, the Delhi government, in collaboration with IIT-Kanpur, conducted cloud seeding on October 28. Due to atmospheric heat, water from oceans, rivers, lakes, and other water bodies evaporates into vapor. The process of converting vapor into liquid droplets is called condensation while the direct transformation of vapor into a solid is called deposition. Condensation occurs with the help of tiny particles suspended in the air. Examples include dust particles, other small particles, or volcanic ash. These tiny particles act as condensation nuclei. Water vapor gathers around these particles (condensation nuclei) and transforms into liquid droplets or ice crystals.


droplets or ice crystals accumulate, a cloud is formed. As the size and weight of these droplets or ice crystals increase, they fall to the earth as rain. This is how natural rainfall occurs.

#### **Cloud seeding:**

Clouds can naturally produce rain. But not all clouds result in rainfall. In cloud seeding, chemicals like silver iodide, dry ice, or salt act as artificial condensation nuclei. These substances are released into moisture-laden clouds using aircraft, rockets, or ground-based generators. The nuclei help form sufficient liquid droplets or ice crystals, increasing their size and weight, thereby inducing artificial rainfall. Like a car with a working engine and fuel that may not start due to a weak battery and needs a push, cloud seeding works when clouds and sufficient moisture are present, but rain does not occur naturally.

#### Clouds may not always

produce rain: Cloud seeding does not



work under clear skies. Insufficient number of condensation nuclei to convert water vapor into droplets or ice crystals. Cloud seeding aims

#### to address such critical issues. How can human activities

affect clouds? Research shows that aerosols released into the atmosphere due to air pollution affect cloud formation and can inhibit rainfall. Aerosols prevent water droplets in clouds from merging into larger, heavier droplets. As a result, the droplets remain very small and continue to float in the atmosphere. Thus, air pollution from urban and industrial activities significantly impacts rainfall patterns.

#### Why the experiment failed in Delhi?

Cloud seeding works only when clouds have around 50 per cent or more humidity. However, in the Delhi experiment, the targeted clouds had only 15-20 per cent humidity, according to Manindra Agrawal, Director of IIT, Kanpur, which partnered with the government for the project. He stated that a chemical mixture of common salt, rock salt, and silver

iodide was used.

### Over 50 countries, includ-

ing Saudi Arabia, the United States, Israel, Indonesia, and Australia, have conducted cloud seeding projects at some point. Some achieved good results, while others saw little or no success.

The United Arab Emirates (UAE) is noted as one of the most successful countries in cloud seeding. It conducts operations annually to increase rainfall and combat severe water scarcity. Reports indicate rainfall increased by 10 to 30 per cent in some areas.

China's success: During the 2008 Beijing Olympics, China successfully used cloud seeding to create favourable weather conditions. To prevent rain during the opening and closing ceremonies, clouds were

# HC DIRECTS GOVT TO ANNOUNCE PANCHAYAT POLL DATE BY NOV 24

THE Telangana High Court on Monday directed the government to inform by November 24 the specific date by which the local body elections will be conducted across the State.

A division bench of Chief Justice Aparesh Kumar Singh and Justice Ghouse Meera Mohiuddin issued the direction while hearing a writ filed by advocate Renka Surender from Mancherial district, challenging the State Election Commission's decision to keep the local body election notification in abeyance.

The bench emphasised that, under Article 243(3), elections to local bodies must be held within six months of expiry of their term. However, the term of the current panchayats expired in January 2024; despite the lapse of more than 18 months, fresh elections have not yet been

During the hearing, the CJ observed that while the government may have to consider several administrative factors, "that does not obviate the timeline which the government and the SEC are required to follow-not more than six months."

The bench referred to an earlier order staying GO 9, which allocated 42% BC reservation, exceeding the 50% cap mandated by the Supreme Court. The HC had directed the government to restrict reservations within the prescribed limit, leading to the election notification, dated September 29, being kept in abeyance.

It may be recalled that Justice T Madhavi Devi, while adjudicating a batch of writs, had directed the government and the SEC to conduct and declare the results of panchayat elections by September 30. However, the directions have not yet been



The bench has now made it clear that the government must take a final decision and communicate the schedule for conducting the elections by November 24.

Court adjourns PILs challenging Kokapet land allotment to BRS

The HC on Monday adjourned the hearing on two PILs against allotment of 11

acres of prime government land in Kokapet to the Bharat Rashtra Samithi party for construction of its office.

The division bench directed the government to file its counter within three weeks and posted the case to the second week of December

The PILs, filed by the Forum for Good Governance through its secretary M Padmanabha Reddy and by advocate A Venkatarami Reddy, challenge the decision of the BRS government to altitioners allege the land, valued at over Rs. 1,100 crore, was allotted to the party at a "throwaway price" of just Rs. 3.41 crore. Padmanabha Reddy's PIL

seeks a stay on the allotment, arguing that the transaction constituted abuse of power and misuse of public assets. The petition filed by Venkatarami Reddy, requests the court to direct the Anti-Corruption Bureau to register a case against the BRS general secretary for allegedly acquiring highly valuable government land under false pretentions.

According to the petitions, the BRS general secretary had originally requested allotment of land spread across survey no 239 and 240 in Kokapet for establishing an institute of excellence and human resource development. However, they allege that the real intent was to use the land for constructing a party office.

that the prevailing market value of land in Kokapet was around Rs. 50 crore per acre at the time, yet the entire 11-acre parcel was alienated to the party for just Rs. 3.41 crore. They contend that the then BRS government misused its authority to acquire valuable lands across multiple districts for its party offices, despite already possessing a large office on a two-acre plot at Banjara Hills.

In May 2023, the then CM had approved the proposal and even participated in the bhoomi pooja for the new party office. Following complaints, the HC in 2024 had issued notices to several officials, including the Chief Secretary, Commissioner of HMDA, Chief Commissioner of Land Administration, Ranga Reddy collector and the BRS general secretary.

For further hearing the case was adjourned to second week of December.

## SC to tackle digital arrests with an iron hand



NEW DELHI: The Supreme Court on Monday expressed shock over the fact that victims across India have collectively lost nearly Rs 3,000 crore to the digital arrests scam.

Hearing a suo motu case initiated to curb the surge in online scams and impersonation rackets, a Bench comprising Justice Surya Kant and Justice Joymalya Bagchi described the situation as "shocking" and stressed the need for urgent and stringent judicial interven-

"It's shocking that almost Rs 3,000 crores have been collected from victims in our country alone. If we ignore it right now and are not able to pass harsh and stringent orders, the problem will magnify. We are determined to deal with it with iron hands," Justice Kant observed after pursuing the sealed cover notes submitted by investigating agencies.

The court was apprised

that these scams often involve cybercriminals posing as law enforcement officers, coercing victims, particularly senior citizens, into transferring large sums of money under false pretexts of criminal charges or investigations.

Solicitor General Tushar Mehta, appearing for the Union Government, highlighted the human cost of these crimes, stating: "Especially the victims are aged people, that's the most pathetic aspect."

Justice Kant emphasised that the Court would not hesitate to issue strong directives if necessary, warning that unchecked digital frauds could erode public confidence in digital governance and law enforcement systems. Earlier, the Court had taken suo motu cognisance of the matter after receiving a letter from a senior citizen couple from Haryana, who were victims of one such cyber fraud.

The Minister announced an ex gratia of Rs 7 lakh, including Rs 2 lakh from TGSRTC, each to the families of the deceased and Rs 2 lakh to those injured.

Following the accident, Ponnam Prabhakar rushed to Chevella and expressed his deep shock over the road accident.

The Minister enquired about the condition of the injured and reviewed the medical treatment being provided to them. The Minister said that a probe has been ordered into the collision between an RTC

bus and a tipper lorry. According to officials, there were 72 people aboard the Telangana State Road Transport Corporation bus, which was coming to Hyderabad from Tandur As many as 19 persons including 13 females, 5 males and an infant died. The Minister said the immediate priority of the government is to ensure the best possible treatment for the injured and extend all help to the families of the deceased.

"An official has been assigned to help the family of each of the deceased in the transport of bodies and in conducting the last rites,"

said Ponnam Prabhakar. The Minister claimed that road safety is the topmost priority for the government. "No matter how many new rules we bring and how many checks we conduct, we need public cooperation to prevent accidents," the Minister observed.

Prabhakar pointed out that every day, hundreds of persons are killed in road accidents across the country, while Telangana reports fewer than 20 deaths daily. The Minister emphasized that the Transport Department is actively addressing danger spots on highways and taking serious action on vehicle fitness and other issues.

During a crucial meeting with Transport Department officials, the Minister stressed that road accidents can be mitigated only if the authorities enforce strict measures in every district with a dedicated action plan. The Department must assess how effectively the speed limit regulations for vehicles are being enforced; if violations occur, a threefold penalty should be

Special Chief Secretary Vikas Raj, Transport Department Commissioner K Ilambarithi, JTCs and DTCs, were present.

Ponnam Prabhakar said: "The DTC, RTO, and other transport lish three teams in every district to ensure continuous monitoring. Strict measures should be enforced against commercial vehicles, passenger transport vehicles, and those transporting mines and minerals that fail to comply with regulations," the Minister said.

The Minister asked the officials to implement precautionary measures to avert further incidents. Ponnam said that in Monday's collision, even though both vehicles were in good condition, the accident occurred due to the absence of even a narrow road divider. Transport officials need to be proactive in their enforcement efforts.

According to the rules, Tata Trusts must implement

board changes approved by the Commissioner within 90 days. Mehli Mistry wants to contest his ouster before the Commissioner of philorganisations anthropic pointing to the October 2024 resolution on life trusteeship at renewal, according to multiple media reports.

The Tata Trusts board had in October rejected Mistry's renewal for life trusteeship, with office holders Venu Srinivasan, Noel Tata, and Vijay Singh opposing his continuation. Noel Tata leads the philanthropic trust, with Vijay Singh and Venu Srinivasan as vice chairmen, according to reports.

Mistry's challenge to oust-

er is based on a resolution from October 2024 that reportedly grants life terms on renewal to current trustees.

"The Trustees recognise that they are all equally responsible, charged with public duty and specifically tasked by Ratan N Tata. To this end, they resolve that on the expiry of tenure of any Trustee, that Trustee will be reappointed by the concerned Trust without any limit being attached to the period of tenure of such reappointment, and in accordance with law," the resolution said.

Tata Trusts has been embroiled in an internal conflict over the nomination of a director to the Tata Sons board. Analyst said that the rift at Tata Trusts would impact strategic decisions at Tata

Tata Trusts -- the charitable arm that controls about 66 per cent of Tata Sons -has been recently mired in internal disagreements.

NEW DELHI: India's whitecollar job market in October 2025 showed notable strength in education, accounting and finance, BPO/ ITES, and specialised tech roles despite a slowdown in recruitment during the Diwali-Dussehra holidays,

The report from the recruitment platform said that India's white-collar hiring experienced a 3 per cent year-on-year growth when adjusted for the 'holiday effect' from the festive calendar shift. The Naukri JobSpeak Index recorded 2,480 points during the month, marking a 9 per cent year-on-year dip, as the Diwali-Dussehra festive cluster temporarily slowed recruitment momen-

Naukri's data revealed pockets of strength within the technology domain. The emerging technologies subsector, which includes companies working on blockchain and cryptocurrency, registered a remarkable 60 per cent YoY growth, showcasing sustained investment in future-forward skills.

Further, hiring activity within IT unicorns remained stable during the month, the release said.

The attached assets include the residence at Pali Hill, Bandra (West), Mumbai, the Reliance Centre property in New Delhi, and multiple assets across Delhi, Noida, Ghaziabad, Mumbai, Pune, Thane, Hyderabad, Chennai (including Kancheepuram) and East Godavari.

These assets include office



premises, residential units and land parcels. The aggregate attached value across the four orders is approximately Rs3,084 crore.

The orders were issued on October 31, 2025 under Section 5(1) of the Prevention of Money Laundering Act (PMLA). The case concerns the diversion and laundering of public funds raised by Reliance Home Finance

Ltd. (RHFL) and Reliance Commercial Finance Ltd. (RCFL). During 2017-2019, Yes Bank invested Rs2,965 crore in RHFL instruments and Rs2,045 crore in RCFL instruments. These turned into nonperforming investments by December 2019, with Rs1,353.50 crore then outstanding for RHFL and Rs1,984 crore for RCFL.

An ED investigation found that direct investment by the erstwhile Reliance Nippon Mutual Fund into Anil Ambani Group financial companies was not legally possible due to Sebi's mutual fund conflict of interest framework.

## India's solar capacity to touch 216 GW in FY28: Report

New Delhi

INDIA is expected to have around 216 GW of solar capacity generating 305 billion units by FY28, driven by strong responses to applications under the Production Linked Incentive scheme, a report said on Monday.

The PLI scheme is enabling rapid capacity expansion, while efficiency gains -- where 1,700-2,200 panels (at 500 watts peak) are typically deployed for every 1 MW of solar power -- are reinforcing scale advantages in project execution, said the report from CareEdge Advisory, a subsidiary of ratings agency CareEdge Ratings.

CareEdge Advisory noted India's installed solar base surged to 127.3 GW as of September 2025, up from 3.9 GW in FY15, and contributed about 25.7 per cent of total installed capacity.

India's exports of solar photovoltaic (PV) products have surged by more than 10 times between FY19 and FY25, primarily to the US, the report said.



Government initiatives like PLI, Basic Customs Duty (BCD), and Approved List of Models and Manufacturers (ALMM) have helped expand domestic solar module capacity to 100 GW, placing the country in fourth position worldwide.

India's module manufacturing capacity is expected to add additional capacity of 100 GWp by the end of FY28, nearly three to four times the average annual module demand of 50-60 GWp over the next three years, the report said.

Domestic cell manufacturing capacity is projected to reach 100 GWp during the same period, with capex exceeding Rs 55,000 crore, driven by backward integration efforts, the advisory noted.

CareEdge Advisory expects that by FY28, India will require an estimated 36-47 crore solar panels (at 500 Wp) to achieve its targeted solar capacity of 215 to 220

The advisory expects module production to increasingly rely on exports, even as cell production is also likely to eclipse domestic demand in the medium term. This indicates that in the coming years, India's module and cell output will exceed domestic requirements, positioning exports as the key growth driver for

Already piloted in classrooms, the app has made a tangible difference—impacting over 30 students, logging 50+ browser plays and 150+ site visits, and earning partnerships with the National Institute of Open Schooling (NIOS) and Pallavanjali School.

His innovation has also earned him the CREST Gold Award from the British Science Association and a nomination for the Inspire-Manak Award 2025 by India's Department of Science & Technology. In this exclusive conversation, Arv discusses his inspiration, challenges, and hopes for making learning more inclusive for all.

#### Excerpts from an interview with Young Hans featuring

#### Arv Jakhodia What inspired you to create Samanta and focus on neurodiverse learners?

I always disliked the rote-learning culture in classrooms. Especially in business studies-students often memorized answers without understanding them. I saw how many of my peers, particularly neurodiverse learners, struggled not be-

#### What role should technology play in inclusive education?

In today's world, everything adapts to technology-except education. When used thoughtfully, technology can personalize lessons and remove barriers of pace or style. It allows students to learn for understanding, not memorization. It's the bridge to make learning truly equal for everyone.

#### What feedback made you realize Samanta's impact?

A visit to Pallavanjali School, I asked students if they preferred rote learning or learning through games. They all said, 'Games are more fun!' Their excitement during the session—the smiles, the eagerness to answer-was

my real reward. Even the teachers, who were initially unsure, later praised how Samanta simplified learning and reduced their workload. That moment assured me this project mattered.

#### What's next for Samanta?

# IIT Madras aces vertical take-off and landing in aircraft, UAVs with hybrid rocket thrusters

Researchers at the Indian Institute of Technology (IIT) Madras have taken India a step closer to advancing vertical take-off and landing (VTOL) aircraft and an Unmanned Aerial Vehicle (UAV) with hybrid rocket thrusters.

In a sophisticated experiment that combined a real-time hybrid rocket thruster with a virtual simulation, the researchers achieved the necessary velocity for 'soft landing' -- a crucial feature for all craft ranging from planetary landing of an unmanned or manned exploration module to terrestrial landing of a VTOL aircraft.

Touchdown velocity is an important parameter to ensure safe vertical landings.

Researchers studied the feasibility of using the hybrid rocket motor for vertical landing platforms, as they are less complicated and safer compared to liquid engines. Moreover, hybrid rocket systems are gaining popularity due to their inherent safety and throttling capabilities, apart from the possibility of combining the advantages of liquid and solid rocket engines

Currently, VTOL systems are complex and need high maintenance. Therefore, the research, published in the peerreviewed International Journal of Aeronautical and Space Sciences, conceived the concept of a hybrid rocket thrusterpowered platform as part of a system development study to bring out an effective propulsion unit for achieving VTOL in aircraft and UAVs.

"Vertical take-off and landing, as the name suggests, will enable an aircraft to take off



and land vertically, eliminating the need for infrastructure like long runways. Because of this, VTOL capability will enable access to remote locations and rugged terrains where long runways and large airports are difficult to establish. Currently, helicopters are the system operating on those terrains; however, they face limitations in terms of speed, range, and efficiency compared to a fixed-wing aircraft," said Prof. PA Ramakrishna, Department of Aerospace Engineering, IIT

"Once the VTOL system reaches the Technology Readiness Level (TRL) for commercial application, it will be a game-changer in both civil and military aviation. VTOL will help to decentralise air transport to multiple locations rather than a single big airport or an airbase. Such decentralisation brings significant strategic and operational advantages. This study is a precursor towards the development and demonstration of a proof-ofconcept for a hybrid rocketpowered VTOL platform,"

Ramakrishna added.

The experts highlighted that a significant contribution is the development of a hybrid rocket fuel that needs only compressed air as the oxidiser. This makes VTOL systems easier to integrate with aerospace vehicles, especially in scenarios where compressed air is readily available. "Another interesting aspect

of this work is the unique

Hardware-in-the-Loop Simulation (HILS) framework that IIT Madras researchers have developed. HILS combines physical hardware testing with simulations to offer a costeffective way to quickly develop complex systems," said Dr. Joel George Manathara, Associate Professor, Department of Aerospace Engineering, IIT Madras. He explained that while typical HILS setups involve a servo motor or microcontroller as the hardware interacting with the simulation, the team integrated a real, live-firing hybrid rocket motor directly into the HILS loop. The hardware-in-the-loop simulation setup demonstrated a successful soft landing of the platform with a touchdown velocity of less than 1 m/s.

During his 10-minute speech, Patnaik also questioned the BJP government's performance in Odisha.



## 6 arrested for routing Rs 200 cr to Dubai-based cyber criminals

AHMEDABAD: The Gujarat rested six persons for allegedly routing Rs 200 crore to Dubai-based cyber criminals using nearly 100 'mule' bank accounts, officials said on Monday

Based on a specific tip off and subsequent investigation, the Gandhinagar-based Cyber Centre of Excellence of the CID-Crime arrested Mahendra Solanki, Rupen Bhatia, Rakesh Lania, Rakesh Dekivadia, Vijay Khambhalya and Pankaj Kathiria from Morbi, Surendranagar, Surat and Amreli districts, they said.

A mule account is a bank account used by criminals to receive, transfer, or launder illicit funds with or without



holder, they added. "Investigators found details of over 100 'mule' bank accounts from the mobile phones recovered from these accused. They provided 'mule' bank accounts to cyber criminals operating in different states and then sent the fraudulently acquired money to Dubai-based crime syndicate through angadia (cash courier service) or through crypto currency transfers," a CID-Crime release said.

Upon checking details on

the Union Home Ministry's found that the 100 bank accounts were used in 386 cyber crimes such as digital arrest, task fraud, investment fraud, loan fraud and part-time job fraud registered across the country, with victims being made to deposit Rs 200 crore

in them, it said. 'The accused, for a specific commission, agreed to provide bank accounts to these cyber fraudsters to help them accept money from the victims. The accused used to withdraw cash from these bank accounts and send it to Dubai-based crime syndicates through 'angadia' (traditional couriers) or through crypto currency transfers," the release said.

#### 'katta' remark PATNA: RJD leader Tejashwi Yadav on Monday hit out at Prime Minister Narendra Modi for his 'katta' remark at

a poll rally in Bihar, asserting that he had never heard any PM use such words.

Modi had on Sunday claimed that the Congress had been unwilling to accept Yadav as the INDIA bloc's chief ministerial, and relented only after the RJD pointed a "katta", a country-made gun, at its head.

Talking to reporters here, the RJD leader said, "I have nothing to say on the PM's comment ... I have never heard any PM in the country use such words. This shows his thought process".

"Whenever the PM goes to Gujarat, he talks about IT factories, semiconductor units and data centres... But when he comes to Bihar, he talks about 'katta," Yadav alleged.

The PM used the simile on the campaign trail in Bihar on Sunday, where he addressed back-to-back rallies in Bhojpur and Nawada districts, and highlighted the RJD's reputation for alleged strong-arm tactics and its troubled equations with alliance partners.

"The Congress never wanted to announce the chief ministerial candidate in favour of the RJD. The RJD secured it by placing a 'katta' on the head of the Congress. They have learnt their lessons in the school of jungle raj. Such elements can never do good for Bihar," he had alleged. The Bihar assembly polls will be held in two phases on November 6 and November 11, while the counting of votes will take place on November 14. (PTI)

### Lankan Navy detains 31 fishermen

## Stalin urges Centre to secure release of TN fishermen

TAMIL Nadu Chief Minister M K Stalin on Monday urged External Affairs Minister S Jaishankar to initiate immediate diplomatic efforts with the Sri Lankan government to secure the release of all the arrested fishermen along with their boats.

The Sri Lankan Navy detained 31 fishermen from Nagapattinam along with their three mechanised fishing boats on November 3, the CM said, adding that in a separate incident, four fishermen from Ramanathapuram district were also apprehended, along with their country

The 31 fishermen had set sail from Akkaraipettai, according to Fisheries Department sources. They were



reportedly intercepted by the Sri Lankan Navy for violating maritime boundaries and were taken to Kankesanthurai Port, sources said.

"These recurrent incidents have caused profound distress among the fishing communities of Tamil Nadu, whose lives and livelihoods are inextricably linked to the sea. Each apprehension not only deprives families of their primary means of sustenance but also instills a deep sense of fear and insecurity," Stalin wrote in his letter to Jaishankar.

According to him, as of now, 114 fishermen and 247 boats are under the custody of Sri Lankan authorities.

Stalin urged the External Affairs Minister to initiate immediate diplomatic efforts with the Sri Lankan government to secure the release of all the detained fishermen from Tamil Nadu along with their fishing boats. (PTI)

# Priyanka mocks PM, says create 'Apamaan Mantrayala'

Saharsa (Bihar)

CONGRESS leader Priyanka Gandhi Vadra on Monday mocked Prime Minister Narendra Modi, saying that he accuses all opposition leaders of insulting the country and Bihar, and should create an 'Apamaan Mantralaya' (Ministry of Insults).

Her comments came just days after Prime Minister Narendra Modi charged the opposition Congress-RJD combine in Bihar with insulting 'Chhathi Maiyya', having "problems with Ram temple at Ayodhya" and "protecting infiltrators" for the politics of vote bank and appeasement.

"Before announcing doles for Bihar during elections, Modi and Amit Shah should

did for the state in the last 20 years," she said. The Congress general

secretary alleged that the Bihar government is being "remote-controlled" Delhi. "Nitish Kumar doesn't run the Bihar government. It is the prime minister and people at the Centre who are running the show," she said.

The NDA government in Bihar is threatening people's right to vote guaranteed by

the Constitution, she alleged. Slamming the ruling alliance over joblessness, she said, "The youth of Bihar are forced to leave the state because there are no jobs here. All major PSUs that used to generate employment have been handed over to big corporates that are friends of the

# 'Navarasa': A mesmerising journey through the nine emotions of Bharatanatyam

n entrancing 'Baithak' or chamber concert at the Raw Mango Showroom in Banjara Hills recently featured the Bharatanatyam ballet 'Navarasa', created by Padma Shri Dr. Ananda

Shankar Jayant. Rasa is an emotion felt by the audience — an experience they undergo when they watch a performance, painting, or any form of art. These rasas are classified into nine, as per Indian aesthetic theory. In the 'Natya Shastra' of Bharata Muni, each of these emoparticular colour - 'Roudra' (red), 'Bhayanaka' (black), 'Adbhuta' (yellow), 'Bhibatsa' (dark blue), 'Veera' (orange), 'Karuna' (grey), 'Shringara' (green), and 'Shanta' (colourless). These form the basic tenets of Indian art — whether dance, music, or painting.

Usually, in a dance recital, the emotions are anchored to the lyrics or storyline. However, if the story is unfamiliar, the audience may not be able to grasp the emotion. Sometimes, an event is not strictly necessary to trigger a mood — it could be spontaneous laughter, anger, or tears. The challenge of conveying these rasas without a storyline inspired Ananda in envisioning this production. This was the genesis of the idea behind the ballet.

When the lyrics or 'sahityam' are omitted, pure music alone remains. The grammar of Bharatanatyam — pure 'nritta' — was explored through group dynamics to create visual framing that expressed emotions not limited to 'abhinaya' but encompassing the entire body as an instrument. The dancers began in pure white costumes serving as a blank canvas on which various colours were projected using light. This visual imagery was masterfully designed by Surya Rao, creating a spectacular feat of lighting and imagination.

The Shankarananda Kalakshetra ensemble, led by Dr Ananda Shankar, included her disciples Sneha Magapu, Poojitha Namburi, Neha Sathanapalli, Srividya Sripathi, and Shreenidhi Ramaswamy.

The order of emotions was slightly altered, as

Exploring the essence of nine human emotions as described in the 'Natya Shastra', the performance was a vivid interplay of light, movement, and expression. Through pure dance and innovative visual imagery, Dr Ananda and her ensemble transformed rasa theory into an evocative experience for the audience

Ananda felt that anger, rather than love, is a more immediate and striking emotion. Thus, 'Roudra Rasa' in 'Atana' raga began the performance with a powerful start. Using 'Shikhara' and 'Pataka' hastas, the dancers moved strongly. A fiery red glow bathed the stage — evoking images of a mob in riot, with pulling, pushing, and tugging movements symbolising collective fury.

'Bhayanaka Rasa' in 'Lavangi' depicted fear as experienced differently by each person. The dancers were instructed to respond to imagined fears — some appearing stunned, others seeking to escape - creating a vivid tapestry of reactions through slow movements and expressive 'abhinaya'.

'Adbhuta Rasa' or wonder was portrayed as a feeling of awe through buoyant, jumpy movements, where each dancer expressed individual astonishment that merged into a collective

illusion of amazement. 'Bhibatsa Rasa' in 'Varali' followed, expressing disgust. The dancers moved as though navigating through dirty water after a monsoon

shower — carefully placing their steps, drawing their hands back with caution segment. to avoid being sullied. The depiction captured the

with grace and restraint. 'Veera Rasa' in 'Amritavarshini' showcased valour through grand, determined movements. Large, elaborate, and firm marching steps were performed both singly and in unison, giving the impression of a heroic procession, radiating courage and strength.

'Karuna Rasa' in 'Dwijawanthi' brought forth grief and sorrow. This emotion, difficult to portray as a contagious wave of sadness moving from one dancer to another — expressed through circular turns and tender interactions. The scene captured the depth of human empathy and shared loss.

'Hasya Rasa' in 'Kathanakuthoohalam' lightened the mood with humour. Through 'adavus' involving bends and stretches that contrasted each other, the dancers created comic effects without slipping into caricature. A delightful vignette featuring pup-

Finally, 'Shanta Rasa' in 'Revati' embodied peace and spiritual tranquillity. This concluding piece reflected meditative calmness, drawing the audience into stillness and introspection

The music throughout served as a screen upon which the 'nritta' was projected, achieving the intended emotional impact to vivid applause. At the end of the performance, each saree used to signify the colour of a particular rasa was hung on a rack — the hanger holding all nine sarees, now a visual testament to the journey through emotion and art, standing as a symbol of completion and harmony. The music was composed by Prema Ramamurthy.

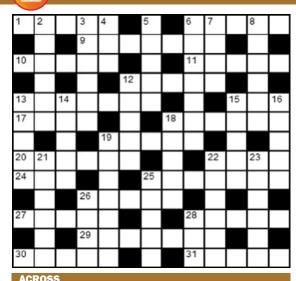



The actor-director added that the film carries deep philosophical undertones. "Every action has destiny. Everyone we meet in this life has a past connection with us. The Bhagavad Gita teaches us to love them without expectation. We've tried to depict that beautifully through this story," he explained. On incorporating Krishna's philosophy, Devan shared, "Ît's a vast subject. I often listened to Gangadhar Shastri's lectures and even consulted him during script development. He clarified my doubts and helped me bring depth to the story. What we visualized on paper has come alive with honesty and emotion."
