

Coordinated efforts urged for Maha Shivaratri at Srisailam

MINISTER ANAM RAMANARAYANA REDDY INSTRUCTS OFFICIALS TO RECTIFY LAST YEAR'S SHORTCOMINGS AND PROACTIVELY ADDRESSING POTENTIAL ISSUES

THE State government has issued directives to ensure smooth, devotional, and hassle-free conduct of Maha Shivaratri Brahmotsavams at Srisailam temple, prioritising devotees' comfort and sentiments.

Endowments Minister Anam Ramnarayana Reddy chaired a comprehensive review meeting at Sadashivayya Bhavan in Srisailam on Monday, attended by Home Minister Vangalapudi Anitha, Roads & Buildings Minister BC Janardhan Reddy, Endowments Commissioner Ramachandra Mohan, Ex-officio Principal Secretary Hari Jawahar Lal, district Collector G Raja Kumari, SP Suneel Sheoran, Srisailem Devasthanam Executive Officer M Srinivasa

Rao, Trust Board Chairman Pothugunta Ramesh Naidu, and other senior officials.

Minister Anam instructed the officials to focus on efficient temple management, darshan arrangements, accommodation, security, sanitation, and essential services. He stressed rectifying last year's shortcomings, proactively addressing potential issues, and strictly adhering to

SOPs. The government aims to prioritise common devotees in all religious events and build a 'Spiritual Andhra Pradesh' with special emphasis on temples. VIP and VVIP darshans will be strictly time-slotted. Despite forest conservation constraints limiting expansion, facilities will be maximised, including support for pilgrims on 48-km forest route. Key an-

nouncements include free laddu prasadam distribution (as last year), free vehicle passage at toll gates on February 14 and 15, night time decorative illumination of the temple, and immediate road widening near Sakshi Ganapathi using Forest Department land.

Home Minister V Anitha directed comprehensive police security, traffic regu-

lation, emergency management, and strict law-and-order maintenance to ensure zero incidents amid the expected massive crowd.

R&B Minister BC Janardhan Reddy ordered completion of repairs, widening, pothole filling, and safety measures on key roads—especially Atmakur to Dornala—by February 8 to prevent traffic disruptions.

Officials noted a projected 30% increase in devotee turnout this year, requiring scaled-up arrangements. District Collector G Raja Kumari confirmed coordinated duties from February 8 to March 18. Executive Officer M Srinivasa Rao presented detailed plans via Power Point. All departments reiterated their commitment to ensuring every devotee experience spiritual fulfillment and satisfaction after darshan.

CM Naidu's efforts brought Budget gains to AP: Minister

BC, EWS Welfare, Handlooms and Textiles Minister S Savitha credited Chief Minister N Chandrababu Naidu entirely for the Central government's priority and substantial allocations to Andhra Pradesh in the Union Budget.

Speaking at a press conference at her camp office in Penukonda on Monday, she highlighted the Chief Minister's frequent Delhi visits and meetings with Prime Minister Narendra Modi, Finance Minister Nirmala Sitharaman, and other Union Ministers as key to securing favourable outcomes for the State.

Describing the Budget as progressive and inclusive, Savitha said it benefits all sections of society. The income tax exemption raised to Rs 12 lakh and standard deduction increased to Rs 75,000 will provide significant relief to salaried

employees, with middle-income earners saving Rs 60,000 to Rs 1 lakh annually. She welcomed the Centre's decision to establish girls' hostels in every district to boost girls' education and the proposal for 'She Marts' at mandal level, which will generate employment for rural women and promote local products.

The Minister outlined major allocations: Rs 500 crore for rural roads, Rs 350 crore for roads and bridges, Rs 800 crore for drink-

ing water and sewerage, Rs 3,320 crore for the Polavaram project, and Rs 1,128.91 crore for Amaravati. She also noted a strong push for handloom and textile sector with mega textile parks proposed at Dharmavaram, Pithapuram, and Mangalagiri. Additionally, bullet train corridors will pass through Andhra Pradesh, with stations planned at Duddabanda and Hindupur in Rayalaseema, promising major economic growth for the region.

Child marriage eradication awareness rath yatra held

Rare kidney transplant successful at Kurnool Medcover

MEDICOVER Hospitals, Kurnool, successfully performed its fifth kidney transplant on January 25 - a rare and complex procedure.

The patient, S Ravindra (48) from Alluru village, Nandikotkur mandal, Kurnool district, was discharged in good health on February 2.

Suffering from kidney failure for four years due to congenital urinary tract issues, Ravindra had been on hemodialysis. His wife K Padmavathi (40) donated her kidney.

The treatment involved three major surgeries: BNI (laser treatment), retroperitoneal laparoscopic nephrectomy to remove the damaged kidney, and the



transplant—all covered under the NTR Vaidya Sree - Aarogyasri scheme.

Dr Abdul Samad, Senior Consultant Urologist & Microsurgical Andrologist, highlighted the challenges posed by congenital condition and credited the team's expertise and advanced technology for the success.

Dr Siddharth Herur, Consultant Nephrologist, noted the transplant's

significant improvement to the patient's quality of life, made possible by timely intervention and government support. Hospital Head Maheshwar Reddy reaffirmed Medcover's commitment to delivering high-quality healthcare to Rayalaseema residents using state-of-the-art facilities and skilled professionals. Both recipient and donor are recovering well.

Prasanthi Nagar land removed from prohibited list

RESIDENTS of Prasanthi Nagar colony in Parigi village, Penukonda division, expressed immense relief after the district administration removed their residential land from the prohibited list under Section 22A, ending a seven-year ordeal.

The 1.65-acre land in survey no. 294 was originally Dyggat patta. With Gram Panchayat approval, a residential layout of 40 plots was developed in 1996, leading to 24 houses and the area being named Prasanthi Nagar, where families have lived for decades.

In 2000, the landowner voluntarily donated 0.11 cents for an Urdu school, which now operates as a government institution.

However, in 2018, the entire extent was mistakenly included in Section 22A prohibited properties list, barring registrations and preventing residents from selling or transferring their plots and homes.

After persistent petitions, the 0.11 cents school land was sub-divided. On February 2 this year, during a Revenue Clinic at the district Collector's office, the Collector issued orders removing the remaining 1.54 acres (Survey No. 294-1B2) from the prohibited list.

Residents, who received the official orders, thanked the district administration and State government for resolving their long-pending grievance and restoring normalcy to property transactions.

YSRCP condemns attacks on leaders, demands President's rule

YSR Congress Party (YSRCP) on Monday strongly condemned recent attacks on senior leaders, including former Ministers Ambati Rambabu and Jogi Ramesh, alleging a complete breakdown of law and order under the TDP-led coalition government in the State. Addressing a protest in Anantapur, YSRCP State secretary and BC Cell State working president Ramesh Goud described the assaults on opposition figures as an attack on democracy and the Constitution. He urged the President and Vice-President to intervene, dismiss the TDP coalition government, and impose President's Rule in the State. "If former Ministers and opposition leaders are unsafe, imagine the condition of ordinary citizens," he pointed out.

Ramesh Goud criticised Chief Minister N Chandrababu Naidu for betraying backward classes despite TDP's BC-friendly claims and warned of intensified agitation if attacks con-

tinue. Earlier, party leaders paid floral tributes at Jyotiba Phule statue near Zilla Parishad office. Speakers, including ZP Chairperson Boya Girijamma and SEC member Meesala Rangananna, accused the government of authoritarian politics and diverting attention from governance.

Mayor Wasim, Deputy Mayor Vasanthi Sahitya, and BC Cell district leaders joined in condemning routine political violence and called for the government to prioritise administration over targeting opposition.
