

# Fishermen families celebrate as they reunite after months of uncertainty

Express immense relief and gratitude upon setting foot on Indian soil once again

SCENES of joy and relief unfolded at Visakhapatnam Harbour here on Monday morning as Indian fishermen, who had been detained in a prison in Bangladesh, returned home safely and reunited with their families after months of uncertainty.

The fishermen reached the harbour by fishing vessel IND-APV5-MM-735. Among them, nine fishermen from North Andhra

Pradesh were arrested on October 22 after their boat accidentally drifted into Bangladeshi waters following an engine failure. They were sent to Bagerhat prison in Bangladesh before being released through dip-

lomatic efforts. The harbour witnessed emotional scenes as anxious family members broke into tears of joy upon seeing their loved ones return safely. Prayers and heartfelt conversations marked the

reunion, bringing an end to months of distress for the families. The fishermen appeared healthy and expressed immense relief and gratitude upon setting foot on Indian soil once again. Following their release,

a message of gratitude was also conveyed through an official post on 'X', thanking the Ministry of External Affairs and senior officials for their intervention.

Officials from the Indian Coast Guard, JD Fisheries-Visakhapatnam, marine police, civil police and leaders of the fishermen community were present at the harbour to receive the returning fishermen.

Expressing gratitude on behalf of the fishing community, Vasupalli Janakiram, president of the East Coast Mechanised Fishing Boat Owners Association, thanked the High Commission of India, the Assistant High Commission at Khulna, the Indian Coast Guard, and officials and public representatives of the Andhra Pradesh government for their diplomatic and humanitarian efforts.

## Bheemili MLA to write to EC for cancellation of Oppn for YSRCP

Says that the conduct of YSRCP leadership had brought 'shame' to the civilised society

Screens the previous comments allegedly made by Jagan Mohan Reddy on various occasions

BHEEMUNIPATNAM constituency MLA Ganta Srinivasa Rao alleged that the use of abusive language appears to be the 'DNA' of the YSRCP and informed that he would write to the Election Commission of India seeking revocation of the party's recognition.

Addressing the media at his camp office here on Monday, Srinivasa Rao said that the conduct of the YSRCP leadership had brought 'shame' to the civilised society. He remarked that people were shocked by the language used by former Chief Minister and YSRCP president YS Jagan Mohan Reddy against Chief Minister N Chandrababu Naidu, one of the country's senior-most political leaders.

To substantiate his statement, the MLA screened the

previous comments allegedly made by Jagan Mohan Reddy on various occasions. He noted that leaders joining the YSRCP too tend adopt abusive and unparliamentary language.

Further, Srinivasa Rao recalled that individuals who had circulated false information about Jagan Mohan Reddy's wife, YS Bharati, on social media were suspended from the Telugu Desam Party. He stressed that politicians must maintain minimum decorum and warned that YSRCP leaders, who are indulging in vulgar remarks, would be remembered as 'shameless'.

Citing former Chief Minister Y S Rajasekhara Reddy, the MLA recalled that he had once gracefully withdrawn

remarks made against Naidu in the Assembly, setting an example for political decorum. The Bheemili MLA said that it was unreasonable to politicise the issue by attributing it to taste when those who committed mistakes were being punished.

Recalling Jagan Mohan Reddy's stand in the Assembly that opposition status would be lost if five or six members switched loyalties from the then 23 members of the TDP, Srinivasa Rao said, "Now, after winning only 11 seats, Jagan is demanding Opposition status. How is that reasonable?" Srinivasa Rao remarked. Party leaders Chikkala Vijay Babu, Ganta Nukaraju, Molli Lakshman Rao, P. Venkatrao, and Gurnath were present.

## Centre eases unmanufactured tobacco tax

RAJAHMUNDY MP Dagubati Purandeswari has drawn the attention of Prime Minister Narendra Modi to the mounting distress among FCV tobacco farmers in the state following the proposed sharp increase in cigarette excise duty. In a detailed letter, she highlighted the dependence of thousands of farmers in the East Godavari region on FCV tobacco cultivation, carried on for decades in the absence of profitable alternative crops. The MP referred to the notification issued on December 31, 2025, proposing a 73 per cent excise duty hike on cigarettes, effective February 1, 2026. She stated that the announcement caused anxiety among farmers, farm workers, women labourers and tribal communities in her constituency.

She argued that FCV tobacco used in cigarette manufacturing was being taxed disproportionately compared to bidis and chewing tobacco, even though several studies have found these products to be more harmful to health.

Purandeswari pointed out that cigarettes already attract far higher taxes per kilogram than other tobacco products, and the proposed revision would widen this gap further. She warned that steep taxation would reduce demand and production, directly impacting farmers' incomes. As per industry estimates cited by her, growers could face a price drop of Rs 50 to Rs 70 per kg, amounting to a 20-25 per cent loss, making it difficult to recover cultivation costs. She also raised concerns that excessive taxation would fuel the illegal and smuggled cigarette trade, which already accounts for about 26 per cent of the Indian market. Smuggled cigarettes, sold at much lower prices, do not use Indian tobacco, resulting in livelihood losses for domestic farmers while benefiting illegal operators.

In a positive development, the Union Budget has addressed one key concern. As per Gazette Notification No 04/2026 issued on February 1, 2026, excise duty on unmanufactured tobacco that is unbranded and not packed for retail sale has been fixed at nil.

## Tiger takes shelter in banana plantation

Forest officials inform that the big cat entered the area around midnight on Saturday, triggering fear among residents of nearby habitations

PANIC gripped Thorredu and the surrounding villages in East Godavari district after a tiger entered the region via Eluru, reportedly taking shelter in a banana plantation at Thorredu village. Forest officials said the big cat entered the area around midnight on Saturday, triggering fear among residents of nearby habitations.

According to officials, the tiger attacked a cattle shed located beside the main road, killing two cows and a four-month-old calf. The carcasses were dragged into a nearby banana plantation, where the animal is believed to be resting. The incident came to light on Sunday morning, following which forest department officials rushed to the spot.

District Forest Officer V Prabhakara Rao, Range Officer N David and other

officials inspected the area. Even as officials and local leaders were present, reports emerged that the tiger fled deeper into the plantation, intensifying anxiety among villagers. Forest officials said the tiger is likely to remain inside the plantation for at least 48 hours, as it had fed sufficiently. They cautioned locals against creating disturbances, warning that the animal could turn aggressive if provoked.

To monitor its movement, the forest department deployed trap cameras and drone surveillance and installed cages to capture the

tiger. A joint rapid response team comprising forest, police and revenue officials has been stationed in the area.

Speaking to 'The Hans India', DFO Prabhakara Rao said there were inputs suggesting that two male tigers had migrated from Chhat-tisgarh through Maharashtra forests.

One is reportedly located in Vikarabad district of Telangana, while the other could be the animal sighted in East Godavari. He said the tiger was likely below three years of age and capable of covering 25 to 35 kilometres in a single night.

Rajahmundry MP Dagubati Purandeswari spoke to forest, revenue and police officials over the phone and instructed them to take immediate steps to safely relocate the tiger to its natural habitat. Rajamahendravaram Rural MLA Gorantla Buchaiah Chowdary, Rajanagaram MLA Bathula Balaramakrishna and RUDA chairman BVR Chowdary visited the site and assured the affected farmer of prompt compensation.

As a precautionary measure, District School Education Officer K Vasudeva Rao announced a one-day holiday on Monday for all government and private schools in Seethanagaram, Korukonda and Rajahmundry Rural mandals. He clarified that the decision was taken considering the possible movement of the tiger in these areas.

However, Regional Intermediate Education Officer I Sarada stated that Intermediate practical examinations on Monday were conducted as per schedule and that the holiday would not apply to these exams.

Officials advised parents to ensure children do not venture outdoors unnecessarily and urged residents to keep lights on near cattle sheds at night and avoid moving alone in vulnerable areas.

## Capacity-building workshop on utility led aggregation model for rooftop solar

APEPDCL has undertaken large-scale awareness campaigns at village, mandal, division and district levels

A capacity building workshop on the implementation of rooftop solar through the Utility Led Aggregation (ULA) Model in Andhra Pradesh was held at the Centre of Excellence for Energy Transition (CoEET) here on Monday.

Addressing the gathering, Chairman and Managing Director of APEPDCL Prudhvi Tej Immadi stated that as part of India's climate commitments, the Union government has launched an ambitious programme to facilitate solar power to one crore households under the PM-Surya Ghar: Muft Bijli Yojana.

The CMD informed that the state currently has around 94,000 consumer-led rooftop solar installations with a total installed capacity of 328 MW. Of them, APEPDCL alone has contributed 44,452 rooftop solar installations with a capacity of 142 MW.

The CMD said that APEPDCL has undertaken large-scale awareness campaigns at village, mandal, division and district levels, including door-to-door campaigns and distribution of pamphlets.

The CMD explained that from application to commissioning, all charges are collected at a single stage, ensuring ease and transparency. The APEPDCL is providing approvals within 3-4 days on average, with a maximum turnaround time of one week, he added.

Further, Prudhvi Tej stated that the government has introduced a utility-led scheme, funding the remaining capital expenditure through the state's subsidy budget, under which eligible domestic consumers are already receiving 200 units of free power per month.

He stated that tenders have been awarded using a division-wise cluster approach, covering all divisions and Letters of Award (LOAs) have been issued to 41 EPC vendors. The project has now entered the criti-

cal implementation phase with material supply already commenced in several divisions, he informed.

The CMD expressed confidence that with the proven efficiency of APEPDCL engineers and coordinated efforts of EPC partners, the project would not only achieve the target of 2 lakh rooftop solar connections but also emerge as a national model for large-scale solarisation of economically backward communities.

APEPDCL Director (Operations) TV Surya Prakash, director T Vanaja, (Projects & HRD), and director (Finance) S Hari Babu, Chief General Managers L Dyva Prasad, and B Ashok Kumar, superintending engineers and executive engineers from 11 districts along with senior officers and EPC vendors were present.
