NO TEXTBOOKS YET CBSE asks schools to start teaching 3rd language in 7 days

NEW DELHI: The Central Board of Secondary Education (CBSE) has made the introduction of a third language (R3) in Class 6 mandatory from the 2026-27 academic session, directing all affiliated schools to comply within seven days, according to an official circular issued on Thursday. Calling the move "urgent and mandatory", the board said all schools must begin implementation immediately, even if textbooks are not yet available. "It has been learnt that many schools have already initiated the implementation of R3... All remaining schools are hereby directed to ensure compliance within 7 days from the date of issuance of this circular," the CBSE said in its notice. Schools have also been asked to start teaching the third language right away, using locally available material until official textbooks are released.

Air India flight makes 'pan pan' call after engine stalls mid-air

MUMBAI: An Air India aircraft makes a 'pan pan' alert while enroute Bengaluru on Thursday. The incident took place on flight AI 2812, an A320 Neo aircraft. The flight, originally to take off at 2.05am, took off at around 2.15am. The aircraft returned to the Mumbai airport at around 2.35am. According to officials the passengers reported soaked during takeoff. One of the officials said, "According to the official information available, there was a sound heard and sparks seen while takeoff. The pilot declared 'pan pan' and returned to the airport a few minutes after takeoff." "It was later known that its engine 2 had stalled," the official added.

ANDHRA Pradesh's Chief Minister N Chandrababu Naidu and his son and IT & HRD Minister N Lokesh have gone on record a couple of times that AP's Amaravati, capital city in the making, will outclass Hyderabad in due course. People who have seen Hyderabad's IT boom under the watch of Naidu as undivided AP's Chief Minister, will not look askance at those statements. Leave alone the arena for competitive growth in IT and other sec-

tors; Amaravati has already gained traction enough to dent Hyderabad's real estate sector, going by the hard talk in certain informed quarters. But will Amaravati really affect the trajectory of the Telangana realty? The

Telangana government too, concerned over this aspect, is studying the ramifications of AP's new Greenfield capital city, which is being developed at a cost of over Rs 70,000 crore, on Telangana's land prices, construction activity,

and investments in realty in the new financial year. The Telangana Registration & Stamps Department has begun analysing the data relating to registration of properties following the recent announcement of

Amaravati as the sole capital of AP. For, already, revenue from registrations in TG decreased to Rs 14, 214 crore in the financial year 2024-2025. It was Rs 14,588 crore in FY24. Although the state government expected huge revenue from property registrations in the 2025-2026 financial year; it remained low in the last financial year too. Given this trend, attributed to Amaravati factor, government officials have started raising doubts over the feasibility of achieving the target relating to revenue

from property registration in the new financial year i.e. FY27. The officials said that the government set a target of Rs 19,540 crore, which is Rs 3,000 crore higher than that of last year. A major challenge for the state government is that some real estate developers in Hyderabad are said to be shifting their focus to Amaravati. Some of these developers have already held meetings with officials in Amaravati to gauge the potential of real estate growth in the new capital in the coming years. **Continued on Page 7**

Modi, Mamata trade barbs at election rallies in Bengal

PRIME Minister Narendra Modi and West Bengal Chief Minister Mamata Banerjee traded barbs at separate poll rallies on Thursday ahead of the upcoming Assembly elections. While PM accused the ruling Trinamool Congress (TMC) of 'cruelty', Banerjee alleged that the Bhartiya Janata Party (BJP) deleted names of more than 90 lakh people from the state's voter lists. At an election rally in Asansol, Modi said that a re-



gime change in West Bengal was inevitable, as the TMC's "repository of sins" has become full. "A regime change in Bengal is now cast in stone and sought by the people of Bengal. TMC's repository of sins is now full. Asansol is being ruled by syndicate raj, coal and sand mafia," the prime minister said. **Continued on Page 7**



US-Iran truce strains amid Lebanon strikes

A two-week ceasefire between the United States and Iran is teetering on the brink of collapse just days after its announcement, as escalating Israeli military operations in Lebanon expose a critical loophole in the agreement. While the truce was intended to pause a month of regional hostilities, both Washington and Jerusalem have explicitly confirmed that the deal excludes operations against Hezbollah in Lebanon, creating a diplomatic and military flashpoint that threatens to reignite the broader conflict. The exclusion of the Lebanese front has drawn sharp condemnation from Iranian officials and international observers. **Continued on Page 7**

Heavy turnout marks high-stakes voting day in Assam, Kerala and Puducherry

NEW DELHI: A surge in voter enthusiasm marked the high-stakes Assembly elections on Thursday, with turnout figures by 3 pm touching a striking 85.21% in Assam, 78.71% in Kerala and 79.40% in Puducherry. Over 5.3 crore electors turned out in large numbers, reflecting robust participation as they cast their votes to shape the political future of the two states and the union Territory. Polling commenced at 7 am and is set to continue until evening across 140 constituencies in Kerala, 126 in Assam and 30 in Puducherry. Officials said elaborate arrangements, including heightened security deployment, extensive webcasting and drone surveillance in sensitive areas, were put in place to ensure free and fair elections. **Continued on Page 7**

WORLD QUANTUM DAY IN AMARAVATI

Indigenous Quantum facility launch on April 14

MARKING World Quantum Day on April 14, Chief Minister N Chandrababu Naidu will formally launch the nation's first indigenous Quantum Computers testing facility at SRM University in Amaravati and simultaneously launch virtually the Quantum facility centre at Medha towers in Gannavaram near Vijayawada. With this, Andhra Pradesh is going to emerge as the first state in the country to commission indigenous Quantum computers testing facility, sharpening the broader vision to make Amaravati Quantum Valley the hub of International Quantum Computers. The Chief Minister will witness a live quantum system initiation with the cooling process of the



processor on the Amaravati IQ system being triggered virtually as the system is housed at Medha towers. At the same time, Amaravati IS system will function as an open access set up fully visible to all attendees during the demonstration. With the setting up of the Amaravati Quantum Reference Facility (AQR), India has now

opened sovereign quantum infrastructure. Amaravati becomes the anchor node of a national quantum hardware network positioning India to design, test, certify, and manufacture quantum systems for the world. Part of the state government's flagship programme Quantum Technology Hub, under the National Quantum Mission, Amaravati Quantum Valley will be hosting an IBM 133-qubit Quantum computer and has engaged 80 plus industry and academic partnerships, positioning it to be among the top five global quantum hubs. The launch of AQR on World Quantum Day adds an indigenous hardware dimension to Amaravati Quantum Valley's portfolio, complementing its existing quantum cloud, skilling, and innovation infrastructure. **Continued on Page 7**

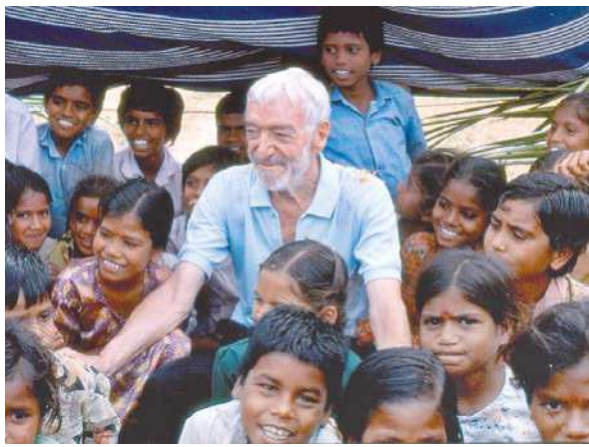
Naidu, Lokesh pay tribute to Vicente Ferrer on birth anniversary

CM hails RDT's service to 25 lakh underprivileged people

CHIEF Minister N Chandrababu Naidu and minister for IT and HRD Nara Lokesh on Thursday paid rich tributes to Vicente Ferrer Moncho, founder of the Rural Development Trust (RDT), on the occasion of his birth anniversary, recalling his immense contribution to the upliftment of the poor in the Telugu states.

In a message posted on X, the Chief Minister praised the RDT for its extensive developmental and humanitarian work, benefiting nearly 25 lakh underprivileged and backward-class people across Andhra Pradesh and



Telangana. He urged people to draw inspiration from Ferrer, who came from Spain and dedicated his life to the welfare of the Rayalaseema region, earning deep respect

among the people. Nara Lokesh, in his tribute, described Ferrer as a "God-given gift" to the poor and lauded his lifelong commitment to social service.

He noted that Ferrer established the Rural Development Trust decades ago and transformed it into a pillar of support for marginalized communities.

Highlighting RDT's contributions, Lokesh said the organization played a key role in building hospitals, educational institutions, housing for the poor, self-help groups, and sports infrastructure, thereby driving inclusive development in the region.

As a mark of tribute this year, Lokesh announced that the government has secured FCRA clearance for the RDT, ensuring that its services continue uninterrupted and reach those in need.

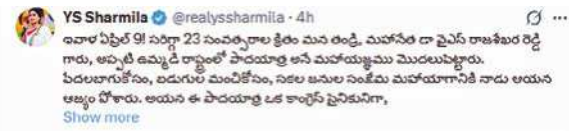

ANDHRA Pradesh Congress Committee (APCC) president Y S Sharmila on Wednesday strongly countered YSRCP chief Y S Jagan Mohan Reddy through a post on Twitter, questioning his commitment to the ideals of their father, former chief minister YS Rajasekhara Reddy.

Marking April 9, Sharmila recalled that it was on this day 23 years ago that Dr YSR began his historic padayatra in the undivided Andhra Pradesh, aimed at the welfare of the poor and marginalised sections. She noted that he undertook the march as a Congress leader and later led the party to power, earning a permanent place in the

hearts of the people.

Taking a sharp dig, she questioned Jagan Mohan Reddy's current political stance, asking how he, as YSR's son and a leader carrying his father's name in the party, is upholding those values. She accused him of

compromising with "fascist forces" and aligning with capitalist tendencies, which she said stood in stark contrast to YSR's pro-poor governance.

Sharmila further said that YSR was a staunch secular leader who worked for uni-

ty among all communities, while alleging that Jagan was now bowing to the BJP out of political compulsion and fear of criminal cases. She criticised what she described as silence on issues affecting Dalits, minorities, and other weaker sections, including matters related to Waqf laws, Dalit Christian reservations, FCRA regulations, and "bulldozer politics."

She also raised concerns over alleged incidents of atrocities on Dalits, women, and minorities during Jagan's tenure, stating that such developments would have deeply disturbed YSR.

Calling Jagan's tributes to YSR "ironic," Sharmila remarked that instead of undertaking a Padayatra, he should embark on a journey of introspection ("Atma Vimsarana Yatra") to reflect on his governance and political choices.

Protests erupt at private hospital after patient's death

- Family alleges medical negligence after 69-year-old man dies post-surgery
- Relatives claim junior doctors operated without senior supervision, sparking outrage
- Police intervene as protests demand hospital closure and criminal cases against staff

A tense situation prevailed outside KIMS hospital in the city on Thursday following the death of a 69-year-old man, identified as A. Venkata Ramana Reddy, a resident of Uppalapadu village in Orvakal mandal. The deceased had reportedly undergone a surgical procedure at the hospital, after which he was declared dead, triggering protests by his family members and relatives.

The grieving family has

alleged that medical negligence led to his death. They claimed that the treatment provided resembled scenes from the Telugu film Tagore, accusing the hospital of unethical practices. According to the relatives, the surgery was conducted in the absence of a senior doctor, allegedly by junior doctors, and there is no clarity on who actually performed the operation.

Family members questioned how the patient could die within minutes of doctors declaring the operation

successful. They expressed suspicion over the sequence of events, stating that the patient was taken into the operation theatre and returned lifeless shortly thereafter. The relatives alleged that the hospital attempted to mislead them by claiming the surgery was successful despite the patient already being in a critical condition.

Demanding accountability, the family staged a protest in front of the KIMS hospital, insisting on a clear explanation from the management. They called for the

immediate closure of the hospital and registration of criminal cases against those responsible. With a large number of relatives gathering at the premises and raising slogans, the situation turned tense, prompting concerns over law and order in the area.

Police rushed to the spot and took stock of the situations. On the assurance given by the police personnel to file a case on the authorities responsible, the victim family members gave up the protest.

CM visits Bapatla police stall

CHIEF Minister N Chandrababu Naidu expressed satisfaction over the measures taken by the Bapatla district police to reduce road accidents.

He inspected the stall set up by the Bapatla District Police Department and expressed satisfaction with the measures being implemented to prevent road accidents.

He attended 'Mee Bhoomi - Mee Hakku' programme held on Thursday at Surepalli village in Bhattiprolu mandal of Bapatla district, where Pattadar passbooks with the government seal were distributed. On this occasion, he visited the police department stall set up at the public meeting venue.

During the visit, Superintendent of Police B Umamaheswar briefed the CM on various initiatives undertaken to reduce road accidents.

He explained that the "Shiro Raksha - Prana Raksha" programme is being implemented to create widespread awareness about

helmet usage. He further informed that wearing helmets will be made mandatory from April 15, and the "No Helmet - No Fuel" policy will be enforced, especially in the district headquarters. To strengthen road safety, six special road safety squads have been deployed to conduct continuous inspections.

Over the past six-months, in coordination with NH authorities, 20 black spots and 78 accident-prone locations have been identified, where safety measures such as speed breakers and reflective barricades have been installed.

Additionally, innovative methods like "Face Wash and Go" to prevent driver fatigue and advanced drone surveillance are being effectively utilised. As a result of these sustained efforts, the district has recorded a 9.47% reduction in road accidents and an 11.63% reduction in fatalities caused by road accidents.

After reviewing these statistics, Naidu expressed satisfaction with the initiatives undertaken by the SP to curb road accidents.

Dy CM launches drinking water project virtually

- Stresses the need to instil confidence and provide security for the future of citizens
- A major drinking water project constructed at a cost of Rs 17.33 crore at Antarvedi was inaugurated

"TRUE development is achieved not merely through construction activities but by improving basic infrastructure and bringing meaningful change in people's lives", Deputy Chief Minister Konidela Pawan Kalyan said on Thursday. He stressed the need to instil confidence and provide security for the future of citizens. He was speaking while virtually inaugurating and laying foundation stones for several development works in the Razole constituency. A major drinking water project constructed at a cost of Rs 17.33 crore at Antarvedi was inaugurated on the occasion. He also laid the foundation stone for rapid sand filter units with a capacity of 6 million litres, being taken up with Rs 5 crore from ONGC funds.

Pawan Kalyan stated that the newly launched

drinking water scheme under the Jal Jeevan Mission would benefit around 30,000 people in 13 villages. As part of the project, a 10-acre pond has been developed along with a water treatment plant having a capacity of 3 million litres and an overhead tank. Water will be pumped from the Gannavaram canal and stored in the pond for supply.

He noted that earlier, drinking water had to be supplied from Antarvedipalem, located about 12 kilometres away, and had to pass through nearly 50 villages, leading to severe shortages. He said the long-standing drinking water problems faced by the region for nearly three decades would now be resolved. The Deputy Chief

Minister further said that once the rapid sand filter units at Gudimellanka are completed with ONGC CSR funds, safe drinking water would be supplied to nearly 1.2 lakh people across 29 villages.

Referring to the goals of the Jal Jeevan Mission introduced by Prime Minister Narendra Modi, he said the state government, under the leadership of Chief Minister N Chandrababu Naidu, is committed to providing 55 litres of safe drinking water per person per day. District in-charge minister Kinjarapu Atchannaaidu, Razole MLA Deva Varaprasad, Konaseema District Collector R Mahesh Kumar and officials of the rural water supply department were present.

3 ANDHRA VILLAGES LEAD RAINWATER REVOLUTION

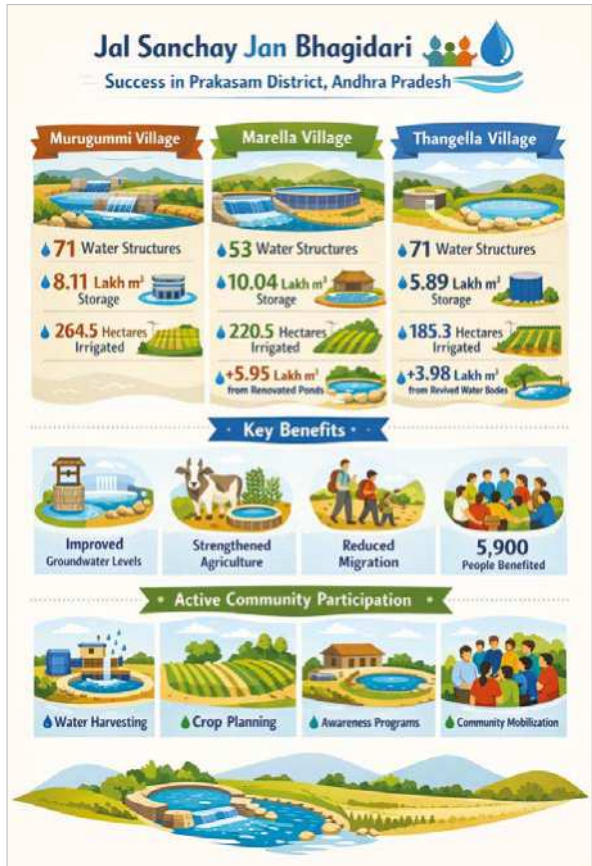
- Murugummi, Marella and Thangella boost groundwater with over 260 water structures, storing nearly 30 lakh cubic metres
- Community-driven efforts like pond revival, rooftop harvesting, crop planning lifted agriculture, dairy, and livelihoods for 5,900 residents
- Murugummi won 2nd-best panchayat at Water Awards 2024; Marella and Thangella also earned honours

NEW DELHI

THREE villages from the coastal district of Prakasam in Andhra Pradesh have emerged as models of water resilience through community-led rainwater conservation initiatives implemented under the 'Jal Sanchay Jan Bhagidari' campaign, the Jal Shakti ministry said on Thursday.

The ministry noted that villages such as Murugummi, Marella, and Thangella have significantly improved groundwater availability, strengthened livelihoods and reduced distress migration through sustained community participation.

Highlighting the outcomes, the ministry said that Murugummi saw the



construction of 71 water conservation structures with a cumulative storage capacity of about 8.11 lakh cubic metres, providing protective irrigation to 264.5 hectares of agricultural land. In Marella, 53 such structures were developed with a cumulative storage capacity of around 10.04 lakh cubic metres, enhancing agricultural sustainability across 220.5 hectares, it

said, adding that renovation of community ponds and tanks contributed an additional 5.95 lakh cubic metres of storage capacity.

Thangella recorded the construction of 71 water conservation structures with a storage capacity of about 5.89 lakh cubic metres, supporting irrigation across 185.3 hectares, while the revival of traditional water bodies added around

3.98 lakh cubic metres more, the ministry said.

The initiative has improved groundwater levels, benefiting around 5,900 people by enhancing access to water for domestic and agricultural purposes, the ministry said in a statement. Earlier, these villages faced acute water scarcity due to erratic rainfall, declining groundwater levels and frequent borewell failures, adversely affecting agriculture and livelihoods, it said.

The ministry said the situation began to change with active community mobilisation through gram sabhas, door-to-door awareness campaigns, Kalajathas (traditional folk theatre), workshops and field demonstrations. Farmers, women, youth and local institutions collectively adopted practices such as water budgeting, crop planning and groundwater sharing, fostering a strong sense of ownership, the statement added. Adopting a ridge-to-valley approach, the villages implemented a range of rainwater harvesting and conservation measures to capture, store and recharge rainwater, including percolation tanks, farm ponds, staggered trenches, rooftop rainwater harvesting systems and the rejuvenation of community ponds.

It also led to enhanced agricultural productivity, increased milk production supporting dairy activities, restoration of soil moisture and reduction in distress migration as livelihood opportunities improved, the statement said. Murugummi village was conferred the second-best village panchayat award at the sixth National Water Awards, 2024, while Marella was among the top 30 villages, and Thangella was nominated for national recognition, it added. War of words erupts as Atchanna targets Jagan, YSRCP hits back

A fierce political confrontation erupted after agriculture minister K Atchanna made allegations against YSRCP chief Y S Jagan Mohan Reddy, triggering a strong and emotional rebuttal from senior YSRCP leader Botcha Satyanarayana.

Addressing a press conference, Atchanna claimed that even leaders within former chief minister Y S Rajasekhara Reddy's own party such as Botcha Satyanarayana, in the past, raised suspicions about Jagan Mohan Reddy's role in his father's death. He alleged that Jagan was driven by an unrestrained ambition for power and would "stop at nothing" to become chief minister. The minister further revived past political controversies, accusing Jagan of amassing wealth during YSR's tenure between 2004 and 2009 by leveraging his father's position. He also questioned Jagan's conduct during the period when YSR's helicopter went missing in September 2009, demanding clarity on his whereabouts at that critical time.

Atchanna also alleged that even before YSR's death was officially confirmed, efforts were allegedly underway to mobilize support for Jagan's elevation as chief minister. He also referred to attacks on a private company establishments following allegations

made at the time, and later political developments involving individuals linked to the same corporate group. In a further escalation, the TDP leader drew parallels with the murder of Y S Vivekananda Reddy, suggesting a pattern of political ambition overriding relationships, remarks that added fuel to the already intense political confrontation.

Reacting strongly, YSRCP senior leader and Leader of Opposition in Legislative Council Botcha Satyanarayana lashed out at Chief Minister N Chandrababu Naidu and the TDP, accusing them of resorting to "cheap and disgraceful politics" for political mileage. Satyanarayana turned emotional while recalling YSR, visibly moved as he condemned the remarks. "Is this the level of politics? Don't they feel ashamed?" he said, alleging that the ruling party was deliberately making provocative statements to divert attention from the positive discussions around the MAVIGUN (Machilipatnam-Vijayawada-Guntur) proposal put forward by Jagan Mohan Reddy.

Satyanarayana asserted that the aggressive response from TDP leaders indicated political insecurity. "The intention is clear - divert the MAVIGUN debate and indulge in personal attacks. There is nothing beyond that," he said.

He also criticised the repeated references to the late YS Rajasekhara Reddy, calling it inappropriate to drag a leader who passed away 15 years ago into current political battles. "Political discourse should have limits. Using deceased leaders for gain reflects the fall in standards," he said.

Rejecting the allegations, Satyanarayana maintained that leadership discussions after YSR's death were natural and that several senior leaders at the time had proposed Jagan's name. He said there were still witnesses who could testify to those developments.

The YSRCP leader further accused TDP ministers of holding frequent press conferences to make "baseless and inflammatory" statements instead of focusing on governance. "If you work well, people will support you. Let the public decide," he added.

Ayyanna calls for 33% youth quota in legislatures

ASSEMBLY Speaker Ch Ayyanna Patrudu said youth play an important role in shaping India's future. He was addressing the Commonwealth Parliamentary Association West Zone Meeting in Goa on Thursday.

Extending greetings to dignitaries including Lok Sabha Speaker Om Birla and Deputy chairman of Rajya Sabha Harivansh Narayan Singh, Ayyanna Patrudu said that the central issue in achieving the vision of a developed India by 2047 lies in increasing youth participation in legislative bodies.

Citing statistics, he noted that only 11 per cent of members in the 18th Lok Sabha and 7 per cent in the Andhra Pradesh Assembly are below 40 years of age, despite the country's average age being around 32. This significant gap, he said, must be addressed to ensure better representation and inclusive policymaking.

He stressed that for youth to contribute meaningfully they must first enter politics and succeed in legislative roles. However, prevailing political practices, including disruptions in legislatures and lack of decorum, discourage young aspirants. He called for exemplary conduct

by elected representatives to restore faith in politics as a respectable profession.

Ayyanna Patrudu also pointed out the decline of student politics, once a vital training ground for future leaders. Reflecting on his own journey, he credited NT Rama Rao for giving opportunities to young individuals without political backgrounds, enabling them to rise in public life.

He proposed a bold re-

form, reserving at least 33 per cent of legislative seats for individuals below 40 years on a rotational basis, similar to women's reservation. Such a step, he said, would infuse fresh energy, innovative ideas, and dynamism into governance.

He reiterated that without creating opportunities for youth, expecting their contribution to national development would remain unrealistic.

Drones Corpn to act as nodal agency for drone ops in AP

Unmanned aerial systems to be used in agriculture, logistics, surveillance, infrastructure and disaster management

THE state government has designated the AP Drones Corporation (APDC) as the exclusive nodal agency for all drone-related activities in Andhra Pradesh, centralising planning, execution and regulation under a single authority.

The decision aligns with the State's Drone Policy 4.0 (2024-29), which aims to expand the use of unmanned

aerial systems across sectors such as agriculture, logistics, surveillance, mapping, infrastructure monitoring and disaster management.

Under the new orders, all government departments, district administrations, public sector undertakings and local bodies must route their drone-related requirements through APDC at every stage, from project conceptualisation to implementation. The corporation will oversee vendor empan-

ment, technical evaluation, execution and operational coordination.

APDC will also act as the central procurement agency for drones and related services, ensuring standardisation and compliance with government procedures. It has been authorised to receive advance payments of up to 90 per cent of the estimated project cost from user departments for executing drone services.

In addition, the corporation will spearhead capacity-



building efforts by coordinating with DGCA-authorized Remote Pilot Training Organisations (RPTOs), academic institutions and other stakeholders to strengthen the drone ecosystem in the State.

APDC will also facilitate regulatory clearances by working closely with the Directorate General of Civil Aviation (DGCA) and other authorities to ensure adherence to national drone rules and airspace regulations.

To support its operations, the government has approved a service charge structure: 5 per cent for projects below Rs 50 lakh, 3.75 per cent for projects between Rs 50 lakh and Rs 1 crore, and 2.5 per cent for projects above Rs 1 crore.

Officials said the move is expected to streamline drone adoption, improve efficiency in public service delivery and position Andhra Pradesh as a leader in drone-driven governance.

THE state government has approved the Request for Proposal (RFP) for developing inland waterways connectivity on the Krishna river linking Muktyala to Machilipatnam port, marking a major step towards strengthening multimodal transport infrastructure in the State.

The project will be executed under the Design-Build-Finance-Operate-Transfer (DBFOT) model through a Public-Private Partnership (PPP), aiming to unlock the potential of inland waterways for cargo, passenger, and tourism movement.

According to the AP In-

land Waterways Authority (APIWA), the proposed corridor spans 168 km, comprising an 82-km river stretch on the Krishna river — part of National Waterway-4 — and an 86-km canal stretch along the Bandar canal.

The proposal follows detailed feasibility studies conducted by WAPCOS, which assessed traffic potential, industrial demand, and infrastructure requirements, particularly for cargo movement such as cement transport

from Muktyala to Machilipatnam. The study recommended navigation using Class-III vessels, along with key interventions including a navigational lock at Prakasam barrage, repairs to existing lock gates, and removal of low-clearance bridges.

The state government's decision comes after stakeholder consultations held in June 2025, where representatives from the Inland Waterways Authority of India (IWAI), government agencies, and

industry participants emphasized the need to develop waterways as an alternative, cost-effective transport mode.

Following this, APIWA floated an Expression of Interest (EoI), which indicated strong market demand for port connectivity through inland waterways, especially in view of Andhra Pradesh's expanding port ecosystem, including operational ports at Kakinada and upcoming greenfield ports at Machilipatnam, Mulapeta, and Ramaya-

patnam. The RFP has already been cleared by the Tender Evaluation Committee and EPC Committee in February 2026. With the government now formally approving the proposal, the project is set to move into the bidding stage. Officials said the initiative is expected to significantly reduce logistics costs, improve connectivity between hinterland industries and ports, and position Andhra Pradesh as a leader in inland water transport on the east coast.

TTD plans expansion of Srivari Seva, ranking system for sevaks

TIRUMALA Tirupati Devasthanams (TTD) executive officer M Ravichandra announced plans to expand the Srivari Seva programme and introduce a ranking system for Srivari Sevaks based on their performance, enabling them to serve in key areas of the temple, including the sanctum surroundings. Speaking to The Hans India, the EO said the initiative aims to strengthen volunteer services and improve pilgrim management across temples.

The EO said that, as sug-

gested by Chief Minister N Chandrababu Naidu, the Srivari Sevak system will be expanded by linking it with nearly 27,000 temples under the endowments department.

Volunteers will be engaged in various services such as regulating pilgrim queues during special occasions, assisting devotees, and

even performing small services like preparing flower garlands.

Based on their dedication and performance, sevaks will be assigned ranks, and higher-ranked volunteers may be given opportunities to serve in important locations within the Tirumala temple.

Ravichandra also said

TTD is focusing on improving accommodation facilities for middle-class devotees. At present, lodging options in Tirumala largely cater to upper, upper-middle, lower-income, and poor sections, while affordable rooms for the middle class are limited.

He clarified that no new buildings will be constructed on the hill, but old and dilapidated structures will be rebuilt and allocated to middle-class pilgrims at reasonable rents. Future expansion of accommodation facilities will mainly take place in Tirupati.

The EO stressed the need to ensure a smoother

darshan experience so that devotees get at least a few moments to pray before Lord Venkateswara. Currently, only 15 to 16 hours a day are available for darshan after accounting for daily rituals, and these rituals cannot be reduced as they follow Agama traditions.

However, changes may be considered in certain Arjitha Sevaks introduced mainly for revenue generation. Since TTD's financial position is stable, some paid services may be modified or conducted in seclusion so that darshan can continue during those periods, after consultations with Agama scholars

and Hindu religious heads.

Ravichandra further said TTD is studying pilgrim footfall patterns over the past decade to increase daily darshan capacity. By identifying days with lower crowd levels and issuing more tokens in Tirupati during less crowded periods on the hill, the number of devotees can be increased.

With the help of artificial intelligence technology, TTD aims to gradually raise the daily pilgrim count from the present 80,000 to 90,000 and eventually to one lakh devotees, while ensuring all decisions strictly follow Agama rules and regulations.

86% pass II PUC exam, girls dominate results

BENGALURU: This year too, girl students have dominated the II PUC exam results. The pass percentage has registered a record increase, with 6.10 lakh students passing out of 7.10 lakh who appeared, translating to an impressive 86 per cent success rate.

Minister Dinesh Gundu Rao said the initiative marks another significant step toward strengthening public healthcare services in the state.

According to the minister, the coverage includes root canal treatments for both anterior (front) and posterior (back) teeth.

The initiative aims to provide timely, affordable, and quality dental care services across Karnataka.

The treatment packages will follow Central Government Health Scheme Tier-3 standard pricing, along with clear clinical classifications to ensure uniformity in procedures and costs.

The scheme will be implemented through the Suvarna Arogya Suraksha Trust (SAST), and will cover all associated treatment expenses. This means patients will not be required to pay any additional charges for eligible procedures, further easing the financial burden on families.



'Women must step forward to make reservation bill effective'

PADMA Shri awardee, Dr Vijayalakshmi Deshmane, on Thursday hailed the Women's Reservation Bill as a historic and bold reform, urging women across the country to actively participate in politics and take responsibility for nation-building.

Notably, after the Parliament's Budget Session reconvenes on April 16, the primary agenda will be to discuss and debate proposed amendments to the Women's Reservation Act, 2023 (Nari Shakti Vandan Adhiniyam), officially known as the Constitution (One Hundred and Sixth Amendment) Act.

Prime Minister Narendra Modi, on Thursday, shared a video message urging collective support for the Women's Reservation Bill by all political parties.

Speaking to IANS, she credited Prime Minister Narendra Modi for pushing forward a long-pending reform, saying that the decision reflects a strong commitment towards women-



led development.

"I would like to begin with a very beautiful slogan — if PM Modi is there, everything is possible. This long-pending, historic Bill had remained pending for a long time. Prime Minister Modi and his Cabinet have taken a very bold decision," Deshmane told IANS.

She emphasised that the Bill is only the first step, and its true success will depend on women stepping forward and making their presence

felt in the political arena. "Now, it is up to the women of the country to take responsibility, enter politics, and make it 100 per cent effective. I request young, dynamic women to come forward, join politics, and contribute to nation-building," she said.

Deshmane highlighted that the move would significantly strengthen India's democratic framework by ensuring greater representation of women in legislative

bodies. "This is the number one step that is going to increase the seats for women in Parliament, and that helps quite a lot in our democratic setup. Democracy is a numbers game. So, this decision will definitely empower women and accelerate the country's progress," she added.

Praising the Centre's broader push for women-led development, she said the Bill presents a "golden opportunity" for women to take leadership roles and shape the future of the nation.

"This is how we can respond to a Prime Minister who believes in women-led development. I thank the Central government, especially Modi ji, for taking such a visionary step. He has done a wonderful job during his tenure," she said.

The Women's Reservation Bill seeks to reserve one-third of seats in Parliament and state legislatures for women, a move widely seen as a transformative step towards inclusive governance and gender equality.

'Too early to draw definitive lessons from West Asia conflict'

DESCRIBING the West Asia war as a critical case study in modern warfare, Chief of Naval Staff Admiral Dinesh Kumar Tripathi on Thursday said it was too early to draw definitive lessons from the conflict. Addressing the 'Ran Samvad' forum on "Maritime Forces -- Visualisation of Multi Domain Operation (MDO)", he said the Indian armed forces were closely tracking developments in the West Asia conflict to derive lessons for future operations.

"It is too early to draw definitive lessons. The war is still going on. We are monitoring what is happening, what is working, what is not working, and learning the correct lessons," Admiral Tripathi said during the question-answer session. The Navy Chief emphasised that one of the most striking takeaways from the conflict is the heightened vulnerability of military assets across domains.

portance of resilience, particularly in sustaining supply chains under prolonged hostilities.

Admiral Tripathi further noted that carrier battle groups continue to remain central to maritime power projection, demonstrating their operational effectiveness even in contested environments, while their vulnerability depends on the adversary's capabilities and the balance of offensive and defensive systems. The Navy chief said the services are analysing the conflict "on a near 24x7 basis" and will incorporate lessons at an appropriate time, stressing that modern warfare now demands constant adaptation to rapidly evolving technological and operational realities.

Emphasising that maritime forces have always operated across multiple domains but now face a far more complex and interconnected battle-space, Admiral Tripathi said the Indian Navy is reorienting its strategy to deliver integrated multi-domain effects in an era defined by speed, scale and simultaneity.

He highlighted the need to align strategic thought with technological capability amid evolving global security challenges and rapid technological advancements. "Today, there is no fixed system of war, no rigid doctrine that we can blindly rely upon,"

Admiral Tripathi said.

The Navy Chief noted that ongoing instability in India's extended neighbourhood, particularly tensions in West Asia and disruptions to maritime traffic, underline the interconnected nature of modern security. He said distance no longer insulates nations from consequences, while technological advances are compressing decision-making timelines and merging operational domains.

Drawing from India's civilisational strategic thought, he said multi-domain operations are not entirely new, citing Kautilya's concept of integrating diplomacy, deception and force. "The pursuit of national objectives extends beyond any single form or domain of conflict," he observed. Explaining the evolving maritime battlespace, Tripathi described it as a "dense yet more transparent, layered yet deeply interconnected grid extending from the seabed to space". He identified three defining attributes shaping this grid -- speed, scale and simultaneity.

On speed, he pointed to artificial intelligence-driven systems that compress decision cycles. "Speed is no longer merely an enabler of warfare, but a distinct capability," he said, noting that modern systems can process vast datasets and enable precision strikes in significantly reduced timeframes. At the physical level, the Navy is restructuring its force to be "capable, resilient, and inherently networked", with seamless integration between sensors and shooters across domains, he noted.

Highlighting indigenous capability, Admiral Tripathi said the Navy's combat management system has evolved into a key enabler of multi-domain operations, integrating inputs across domains for faster decision-making and coordinated engagement.

Spl court adjourns verdict in BJP leader's murder case to April 15

THE Special Court for MLAs/MPs in Bengaluru has adjourned the pronouncement of its judgment to April 15 in the murder case of BJP leader and Zilla Panchayat member Yogesh Gowda, in which sitting Dharwad Rural Congress MLA Vinay Kulkarni is an accused.

The case dates back to 2016 and the court will also decide the fate of 21 other accused in connection with the incident. The court was scheduled to deliver the verdict today. It stated that the pronouncement of the judgment is in its final stage. Counsels

representing both sides have submitted thousands of pages of Supreme Court judgments in reference to this case.

Vinay Kulkarni and the other accused persons were present in court. Vinay Kulkarni is listed as accused number 15. The case was handed over to the Central Bureau of Investigation (CBI) by the state government. At the time the allegations surfaced, Kulkarni was serving as a minister and district incharge minister.

Yogesh Gowda was hacked to death by a group of assailants at a gym in Dharwad city on June 15, 2016. He had politically

challenged Kulkarni, and the incident soon took a worse turn.

Kulkarni was arrested in 2020 and released on bail in 2021. He was accused of influencing witnesses, following which the CBI sought cancellation of his bail, alleging violation of bail conditions. The court accepted the plea and revoked his bail.

Subsequently, Kulkarni, who is currently the Chairman of the Karnataka Urban Water Supply and Drainage Board, surrendered before the authorities and was recently released on bail again.

It may be recalled that Kulkarni was accused of

conspiring in the murder of Yogesh Gowda.

THE High Court has dismissed a Public Interest Litigation (PIL) seeking to declare as invalid the Centre's protocol guidelines on singing all six stanzas of Vande Mataram, ruling that the song is not mandatory like

the national anthem.

The petition was filed by Bengaluru-based advocate Somashekar Rajavanshi and was heard by a division bench comprising Chief Justice Vibhu Bakhrui and Justice Vibhu Poonacha.

At the outset of the hearing, counsel appearing for the Centre clarified that the

Ministry of Home Affairs' order uses the term "may be sung," which indicates that singing Vande Mataram is not compulsory. The counsel also pointed out that the Supreme Court of India had recently dismissed a similar plea on the issue.

Accepting the argument, the High Court observed that Vande Mataram has not been incorporated into any statutory framework mandating its singing. The bench noted that the wording in

the Centre's order reflects a permissive, not mandatory, approach. Referring to the Supreme Court's stance, the court ruled that the song cannot be equated with the national anthem in terms of compulsion and dismissed the petition.

Background of the case The petitioner had challenged guidelines issued by the Ministry of Home Affairs, which were published on its official website regarding national songs. The plea

argued that the directive effectively mandated schools to sing all six stanzas of Vande Mataram daily before the commencement of classes.

It was contended that the Constituent Assembly had recognised only the first two stanzas for general use, while later stanzas include references to Hindu deities such as Durga, Lakshmi and Saraswati.

The petitioner argued that making all six stanzas compulsory could violate consti-

tutional provisions, including Articles 14 (equality), 25 (freedom of conscience) and 28 (prohibition of religious instruction in educational institutions).

The petition also sought directions to limit the singing to the first two stanzas in schools and to restrain authorities from enforcing the remaining portions, particularly in government and aided institutions.

It further urged that bodies like the National Com-

mission for Minorities and the National Commission for Protection of Child Rights examine the potential impact of such guidelines on minority communities.

However, the High Court held that there was no legal basis to treat the guidelines as mandatory and declined to interfere. The ruling reinforces that while Vande Mataram holds significant national importance, its singing remains voluntary and not legally enforceable.

Tepid campus hiring reflects changing contours of IT industry

CAMPUS hiring of engineering graduates has been moving at a snail's pace in recent years. One of the major employers, which are Indian IT firms— are altogether missing or hiring very low numbers. According to HR consultancy firm— Xpheno, fresher hiring in India's IT sector has fallen from a peak of 600,000 in FY22 to about 120,000 in FY25. Many analysts see no change in the overall numbers for FY26, which will be known in a few weeks.

Such tepid hiring trend is driven by a combination of factors. Firstly, demand environment in the IT industry remains subdued. With geopolitical situation remaining volatile owing to Russia-Ukraine war, Iran versus US & Israel conflict and Trump tariffs; enterprises

are cautious in their technology spend since last financial year.

Especially, the US government's decision to impose tariffs on its trading partners has created an uncertainty in several sectors. Though deal pipeline remained robust for most Indian IT companies, the implementation rate of those projects was low. That is the reason that freshers are not required in large numbers as they used to be in earlier years. Second and the most important change has been driven by adoption of AI (artificial intelligence)-powered solutions in the industry.

Many of the entry-level works are getting automated through agentic AI tools. It means companies no longer require as many fresh engineering graduates as

compared to previous years. Such fundamental shift is driving the recruitment trend in engineering colleges. For three decades, Indian IT industry's operational model has been focussed heavily on hiring of new engineering graduates from college campuses.

In a project, freshers and junior employees with 2-3 years of experience comprise the bulk of the man power. Such employee pyramid has helped IT services companies to keep their employee cost lower as entry level salaries remain low for the industry as whole. However, such established operating model is going through a shift as of now. Many L1 & L2 work loads are being handled by agentic AI tools in recent quarters.

In a way, these AI tools should

be seen as responsible for replacing new engineering graduates in India for now. Do these factors make engineering graduates redundant in the evolving landscape? Answer to this question is still not known to the industry. Because Accen-ture- world's biggest IT services & consulting company- recently added headcount by hiring freshers.

The CEO of Accenture has said during analyst call that AI will create more jobs for freshers with new roles emerging under the AI domain. This is in contrast to the popular narrative given by analysts, company management and other stakeholders for the last two years. So, no body exactly knows how fresher hiring landscape will evolve in the coming quarters.

But one view that has started

rolling out from HR experts in recent months is that AI is creating demand for new kind of roles. Job roles like prompt engineer, AI ethics analyst, AI data scientist, AI Product Manager, AI product developer, AI data curator, AI integration consultant and others are getting created with the development of AI. It means new job roles are getting created for which young graduates need to be trained for leading in the future. Therefore, the demand for freshers may have come down temporarily but is likely to continue in the wake of new technology developments. Moreover, Indian IT industry's whole operating model revolves around hiring freshers and any pivot from such established way will take time to evolve.

When global fragility becomes everyone's burden

SEARCH FOR STABILITY IN AN UNEQUAL GLOBAL ORDER

WHEN fuel prices surge on the streets of Colombo, fertilisers slip beyond the reach of African farmers, and Asian governments exhaust fiscal space to hold down subsidies, the reflex explanation is domestic mismanagement. That diagnosis is convenient—and often wrong. The drivers of these crises are frequently located far from national capitals, embedded in strategic decisions taken by a handful of power centres whose economic aftershocks travel effortlessly across borders. Contemporary conflicts may be geographically contained, but their costs are anything but.

This asymmetry—between where decisions are made and where consequences are felt—has become a defining feature of the global order. Power is concentrated; risk is globalised. Energy markets, shipping routes, insurance premia, and capital flows no longer merely reflect economic fundamentals. They have become transmission belts for geopolitics, carrying strategic intent into household budgets, food prices, and balance sheets across the developing world.

History makes this pattern unmistakable. The oil shocks of the 1970s did not remain an OPEC-West confrontation; they translated into 10-15 per cent inflation and debt crises across much of the Global South. The 1991 Gulf War and the sanctions regime that followed erased nearly half of Iraq's GDP, but their secondary effects reverberated through energy markets and regional

economies. The lesson was clear even then: when conflict intersects with global systems, its radius expands dramatically.

Globalisation was supposed to temper such outcomes. Interdependence, it was argued, would raise the cost of conflict and therefore restrain it. In practice, interdependence has done something else—it has accelerated the export of conflict-related costs. The Russia-Ukraine war of 2022-23 offers a textbook illustration. Wheat prices rose by 35-40 per cent; fertiliser exports were disrupted by 20-25 per cent. For low- and middle-income countries, this translated into food inflation of 8-12 per cent, fiscal stress, and renewed balance-of-payments pressures. The war did not have to be global to destabilise global livelihoods.

The problem intensifies when conflict threatens strategic chokepoints. The Strait of Hormuz, through which roughly a quarter of the world's seaborne oil trade—and significant volumes of LNG and LPG—passes, has once again become a pressure point amid escalating tensions involving the United States, Israel, and Iran. Even limited disruption here sends oil prices swinging and insurance costs soaring, with immediate consequences for transport, manufacturing, and household energy bills far beyond West Asia. Geography, in such cases, becomes a multiplier of instability.

What emerges is a consistent sequence. Strategic choices are taken first, often

with narrow security or political objectives. Economic consequences follow later, diffusing through global markets. Advanced economies, cushioned by deeper capital markets and institutional buffers, absorb part of the shock. States with limited fiscal capacity and high import dependence absorb far more. When Papua New Guinea's Prime Minister James Marape remarked that countries like his are forced to pay for conflicts in which they have no role, he was not making a moral appeal; he was describing a structural reality.

This is why the prevailing international order increasingly looks less like a system that resolves imbalances and more like one that manages them—often poorly. It reacts

to crises after costs have already been socialised across vulnerable economies, rather than preventing those costs from being externalised in the first place.

It is in this context that India's contemporary diplomacy merits attention. Its shift from Cold War non-alignment to present-day multi-alignment is not rhetorical flexibility; it is strategic realism. India's engagement with the Global South has focused less on symbolism and more on stabilisation—through vaccine diplomacy, food and fertiliser assistance, and diversified energy sourcing. Securing permanent membership for the African Union in the G20 was not merely an act of inclusion; it linked representation to agenda-setting

in the world's premier economic forum.

Yet stabilisation cannot rest on ad hoc measures alone. The next phase demands institutional ballast. Groupings such as BRICS and the wider Global South offer part of the answer, not as ideological counterweights but as shock absorbers. Instruments like the Contingent Reserve Arrangement and the New Development Bank, combined with local-currency trade and cross-border payment systems, can reduce exposure to volatile capital flows and dollar liquidity cycles. Their promise, however, depends on political discipline—on whether members can place collective resilience above bilateral competition. Still, alternative platforms are not substitutes for systemic reform. The architecture of global governance itself must be recalibrated to internalise the costs it currently externalises. Sanctions regimes need clearer economic impact assessments; trade rules must become more flexible in the face of supply-chain disruptions; financial systems require mechanisms that prioritise crisis liquidity for vulnerable economies.

Coordinated responses through the United Nations could strengthen multilateral crisis management, while the World Trade Organisation needs the mandate and agility to keep trade flowing during geopolitical shocks. In parallel, the United Nations Security Council must become more representative

and more accountable, particularly when sanctions and interventions impose diffuse economic costs far beyond their intended targets.

Representation alone, however, is insufficient without accountability. Emerging powers must deploy their growing economic weight not just to expand markets, but to shape rules. Rule-making, not rule-following, is where lasting stability is built.

None of this assumes an end to power politics. Competition will persist; rivalry is intrinsic to international life. The challenge is not to abolish it, but to contain it within frameworks that dampen volatility rather than amplify it. If that effort fails, global fragility will cease to be episodic and become structural—a permanent condition rather than a recurring crisis.

A more inclusive and accountable decision-making order would not eliminate conflict, but it could prevent its costs from being indiscriminately exported. Stability, then, would no longer be a privilege enjoyed by a few resilient economies, but a shared global public good. The question confronting the international system is stark: will competition be allowed to slide into cascading instability, or will it be balanced by cooperation capable of sustaining a more predictable world?

BR Ambedkar: A national thinker and reformist beyond misconceptions

BR AMBEDKAR, whose birth anniversary is celebrated on April 14, is often misunderstood, seen narrowly as a Dalit leader or as a critic of Hinduism. The fact is that he was neither anti-Hindu nor anti-national. He was a reformer who challenged social injustice, not religion itself, and a patriot who sought to strengthen India's unity through justice and fraternity. His writings and books reveal a thinker deeply committed to building a modern, democratic India.

Ambedkar's intellectual legacy is preserved in his books, which show the breadth of his concerns. In *The Problem of the Rupee: Its Origin and Its Solution* (1923), his doctoral thesis at the London School of Economics, he analysed India's monetary system and argued for a managed currency. This was not a sectional concern but a national economic vision, anticipating debates that would later shape India's financial policy. In *Annihilation of Caste* (1936), perhaps his most famous work, Ambedkar evaluated caste as a social system, not Hinduism as a faith. He argued that caste was incompatible with democracy and justice, and importantly, appealed to Hindu reformers to reinterpret scriptures in ways that aligned with equality.

His *Thoughts on Linguistic States* (1955) examined how India should reorganize states based on language, showing his concern for national integration and federal stability. Finally, *The Buddha and His Dhamma* (1957), published posthumously, outlined his interpretation of Buddhism as a rational, ethical, and egalitarian philosophy. His turn to Buddhism was not anti-Hindu but a reaffirmation of India's plural spiritual heritage.

Ambedkar's take on caste was often misread as hostility toward Hinduism. In An-



nihilation of Caste, he wrote: "The Hindu society must be reorganized on a religious basis which would recognize the principles of liberty, equality and fraternity."

This shows he was not rejecting Hinduism but urging reform so that its ethical core could shine through. His challenge was to social practices, not to faith itself. He believed that religion, when aligned with justice, could be a force for national unity.

Ambedkar's nationalism was pragmatic and ethical. In *Thoughts on Linguistic States*, he warned that ignoring linguistic identities could weaken India; however, his solution was not separatism. Instead, he proposed a federal structure that respected diversity while preserving unity. Similarly, his role in drafting the Constitution was a patriotic act, as he embedded safeguards for minorities and fundamental rights to strengthen the country's democratic fabric.

In his final speech to the Constituent Assembly, Ambedkar cautioned against hero worship and authoritarianism, saying democracy in India must rest on "constitutional morality." Such warnings were not anti-national; they were protective of India's demo-

cratic experiment. His economic writings reveal his concern for national development. In *The Problem of the Rupee*, Ambedkar argued for stability in currency to protect India's economy. He also wrote on agricultural reforms, advocating redistribution of land to ensure productivity and fairness. These were not sectional demands, but national policies aimed at uplifting all Indians. His economic vision was about creating a fair system for all, ensuring that India's modernization did not leave its rural majority behind.

Ambedkar's embrace of Buddhism was a reclamation of an Indian tradition that embodied rationality and compassion.

In *The Buddha and His Dhamma*, he presented Buddhism as a philosophy of equality and ethics. His choice was not a rejection of India's heritage but a reaffirmation of its pluralism. He sought a spiritual foundation for modern India within its own civilizational resources. By turning to Buddhism, Ambedkar was not abandoning the country's traditions but reinterpreting them to meet contempo-

rary needs. Ambedkar's vision of democracy went beyond institutions. He insisted democracy must be a social ethic, respect for dignity, equality of opportunity, and fraternity. His writings and speeches consistently warned that political democracy could not survive without social democracy. This was a profoundly nationalist concern, as he wanted India's democracy to endure and flourish. His insistence on fraternity was not divisive but integrative, binding India together across caste, religion, and language.

Examples of his national spirit abound. In the Constitution, Ambedkar ensured fundamental rights and affirmative action were enshrined in law, not to divide but to integrate India.

His work on currency and agriculture addressed national stability and growth. His ideas on linguistic states balanced diversity with unity. His call to reinterpret Hindu scriptures was aimed at strengthening India's moral foundation. Each of these contributions shows a thinker deeply invested in India's future, not an adversary of its traditions or unity.

Ambedkar was not anti-Hindu or anti-national. He was a reformer who sought to purify religion of social distortions and a patriot who worked tirelessly to build a just and united India. His books—*Annihilation of Caste*, *The Problem of the Rupee*, *Thoughts on Linguistic States*, and *The Buddha and His Dhamma* illustrate his breadth as a thinker.

His legacy is one of integration, bringing together India's ancient values and modern aspirations. To honour Ambedkar is to recognize him as a national visionary whose ideas belong to all Indians.

Three teenage girls drown while taking selfies

A tragic incident claimed the lives of three teenage girls in Alluri Sitarama Raju district on Thursday after they accidentally slipped into a waterfall while attempting to take selfies.

The incident occurred near a waterfall close to Mulagummi village in Ananthagiri mandal. Another girl who fell into the water along with them is reported to be in critical condition.

According to police, the deceased have been identified as Trisha (17), Ratna Kumari (16), and Pavitra (16), all residents of Jumbavala village in Hukumpeta mandal. The girls had recently appeared for their Intermediate examinations

Anjali, who sustained serious injuries in the incident, was rescued by locals and shifted to a hospital in Lungaparti. Doctors said her condition remains critical. Police rushed to the spot and launched rescue operations. The bodies were shifted for post-mortem examination, and a case has been registered, and an investigation is underway. The deaths of the three girls have cast a pall of gloom over their native village.

Parents demanded strict action against the college management, stating that their children's future has been jeopardised.

Guntur RDO N Srinivasa Rao said 15 students were not allowed to write the NEET exam. The RDO and police officials are holding discussions with the college management till late in the night.

He also stated that 1.37 lakh acres of service inam lands are being removed from the prohibited 22A list, with more land to be freed in phases.

US ready for next conquest: Trump

"All US ships, aircraft, and military personnel... will remain in place in, and around, Iran, until such time as the REAL AGREEMENT reached is fully complied with," Trump wrote on Truth Social. "If for any reason it is not...the 'Shootin' Starts', bigger, and better, and stronger than anyone has ever seen before." Trump reiterated that it was agreed that Iran will not develop nuclear weapons, and the Strait of Hormuz will be open and safe for commercial shipping. "In the meantime our great Military is Loading Up and Resting, looking forward, actually, to its next Conquest," Trump added. He ended the post, which was published near midnight, with a declaration: "AMERICA IS BACK!"

The statement came a day after Washington and Tehran agreed to a two-week ceasefire brokered by Pakistan, which halted six weeks of fighting and sparked a brief relief rally in global markets amid growing optimism that energy flows may resume in the Strait of Hormuz.

Iran said safe passage through the strait would be possible but subject to coordination with its armed forces. But much remained unclear in the ceasefire agreement, with the US and Iran appearing far apart in demands. Tehran had rejected the 15-point proposal from Washington and reportedly presented a 10-point plan of its own to end the conflict, including an end to Israeli strikes against Hezbollah in Lebanon and the lifting of all sanctions.

Modi, Mamata trade barbs at election rallies in Bengal

He alleged that Mamata Banerjee's TMC has only inflicted 'nirmamta' (cruelty) on Bengal, while the BJP has developed Asansol despite obstacles posed by the ruling party. The PM also highlighted a downward trend in the state's economy and its contribution to national gross domestic product (GDP). He said, "Bengal's contribution to the national GDP has slid to mere five per cent from 12 per cent earlier." However, he said, a regime change would ensure that West Bengal scales new heights.

"Investment has taken flight from the once-thriving industrial belt of Asansol. Only the BJP's double-engine can rectify it," he added, noting that the Centre has allocated Rs 45,000 crore for the revival of the industries in

Asansol.

In another rally in Haldia, PM Modi said that it is essential to remove the TMC's 'Niram sarkar' to usher 'Viksit Bengal'. He also announced "six Modi guarantees" for the people. The TMC supremo, meanwhile, accused the BJP of deleting names of more than 90 lakh people from the voter lists to grab power in the state, asserting that her party will win the upcoming Assembly polls.

Speaking at a public rally in North 24 Paraganas' Minakhan, Banerjee said that TMC would approach the court to ensure that all the deleted names are reinstated in the electoral rolls, referring to the special intensive revision exercise in the state. "You deleted names of over 90 lakh people to grab power in Bengal, but we will win," she said.

15 ships a day

TEHRAN

SHIPPING traffic at the Strait of Hormuz remained at a virtual standstill amid Iranian regulation, despite the ceasefire, on Thursday, with little movement. Several reports said Iran will allow no more than 15 vessels to pass per day, with Iran's deputy minister earlier saying that ships will need to obtain consent from the military. One oil product tanker and five separate dry bulk carriers reportedly sailed through the Strait of Hormuz in the past 24 hours on Thursday, Reuters reported. Two Iranian-flagged tankers also sailed through Hormuz. Iran will allow no more than 15 vessels per day to pass through the Hormuz under the ceasefire agreement, Russia's TASS news agency reported, citing Iranian official sources.

US-Iran truce strains amid Lebanon strikes

Following a massive wave of Israeli strikes that killed at least 254 people and injured over 1,100 across Lebanon, Tehran declared that it views the ongoing bombardment as a direct breach of the spirit of the ceasefire.

Iranian Foreign Minister Abbas Araghchi stated that Washington must now choose between a comprehensive ceasefire or continued war by proxy, warning that the current status is unsustainable.

The instability has immediate consequences for global energy security. In response to what it terms an Israeli violation of the ceasefire, the Iranian Islamic Revolutionary Guard Corps (IRGC) has maintained a closure of the Strait of Hormuz, a vital artery for global oil shipments.

Shipping executives remain in a state of high alert as they attempt to navigate the uncertainty, while oil prices have reacted sharply to the supply risk. Brent crude futures rose 2.1% to \$96.75 a barrel, and West Texas Intermediate surged 2.6% to \$96.89, reflecting market anxiety over the potential for long-term supply chain disruptions.

Despite the deteriorating situation, US and Iranian delegations are still scheduled to meet in Islamabad this weekend to finalize the terms of the truce. However, the diplomatic path forward is fraught with obstacles.

President Donald Trump has issued a stern warning, stating that US military assets will remain in place around Iran until a real, fully compliant agreement is established.

Trump seeks Europe's help on Hormuz

WASHINGTON: United States President Donald Trump has stepped up pressure on his European allies to commit military forces in the Strait of Hormuz, ahead of talks with Iran on Friday. This comes even as the White House is considering the withdrawal of US troops out of NATO countries. According to two diplomats, NATO Secretary General Mark Rutte has informed European leaders that the US President is expecting concrete commitments for Hormuz regarding the deployment of warships or other military capabilities from Europe in the next few days. This was followed by Trump's post on Truth Social, wherein he stated that NATO would not "understand anything" without pressure upon them.

Iran publishes chart showing sea mines in Hormuz

DUBAI: Semiofficial news agencies in Iran published a chart Thursday suggesting the country's paramilitary Revolutionary Guard put sea mines into the Strait of Hormuz during the war, in a message that may be intended to pressure the US as uncertainty hangs over a days-old two-week ceasefire and further negotiations are expected in Pakistan.

The shaky ceasefire has been largely holding between the US, Israel and Iran, although Tehran and Washington have offered vastly different explanations of the initial terms. Israel insists the agreement does not apply to their war against Hezbollah militants in Lebanon and have escalated deadly strikes there, leading Iran to claim it is violating the deal.

Meanwhile, Iran said it had

won agreement that it would control the Strait of Hormuz, charge tolls and enrich uranium - while Trump said the deal called for the strait to be reopened and Iran to hand over its uranium stockpile. The chart of the Strait of Hormuz was released by the ISNA news agency, as well as Tasnim, which is believed to be close to the Guard.

They showed a large circle marked "danger zone" in Farsi over the Traffic Separation Scheme, which was the route ships take through the strait, the narrow mouth of the Persian Gulf through which 20 per cent of all oil and natural gas traded once passed. The chart suggested ships travel further north through waters closer to Iran's mainland near Larak Island, a route that some ships were observed taking during the war.

Indian women top medal charts with 4 gold

Ulaanbaatar(Mongolia): The Indian women's team delivered a historic performance at the Asian Boxing Championships 2026, finishing on top of the medal charts with a total of 10 medals, including four gold, two silver, and four bronze, underlining their dominance at the continental stage.

Under the stewardship of head coach Santiago Nieva, every member of the women's team returned home with a medal, stamping their authority on the continental competition. With Boxing Federation of India President Ajay Singh in attendance, Minakshi Hooda (48kg) got



things going by claiming the first gold of the day with a commanding 5-0 victory over Mongolia's Nomundari Enkh-Amgalan. Preeti (54kg) continued her sensational run, defeating Chinese Taipei's Huang Hsiao-wen, a three-time world champion and Tokyo 2020 Olympic bronze medalist, by a unanimous 5-0 decision to secure

the top podium finish.

Priya (60kg) added to India's gold tally with a clinical 3-0 win over North Korea's Won Un-gyong in the final. Arundhati (70kg) also impressed, registering a 4:1 victory against Kazakhstan's Bakyt Seidish to clinch gold in her category.

India added two silver medals to its tally, with Jais-

mine (57kg) finishing runner-up after a strong campaign, while Alfiyan Pathan (80+kg) also secured silver following her final bout.

Earlier in the week, two-time world champion Nikhat Zareen (54kg), Ankushita Boro (65kg), Lovlina (75kg) and Pooja (80kg) had settled for bronze medals after semifinal exits. Having confirmed 16 medals, the most of any nation in this edition, India will be looking to finish the tournament strongly, with two men's boxers - Vishwanath Suresh (48kg) and Sachin Siwach (60kg) - in their respective finals on Friday.

RCB have a settled top-order under the watch of the talismanic Virat Kohli, who hasn't shown any signs of rust despite stepping away from T20 internationals in 2024, while Phil Salt also unleashed his explosive abilities in the previous game. Batting one down, Padikkal has carried his domestic form seamlessly into the IPL, signalling a return to his fluent best with an aggressive yet controlled approach. Padikkal had made

an immediate impact in his debut IPL season, scoring 473 runs for RCB and establishing himself as a stylish batter.

However, subsequent stints with Rajasthan Royals and Lucknow Super Giants didn't

quite yield the desired returns.

His return to Bengaluru last season, by his own admission, proved to be a turning point, as he played a key role in the franchise finally clinching their maiden title.

The left-hander has begun this season in similar vein, striking back-to-back fifties-- a 29-ball 50 against Chennai Super Kings and a 26-ball 61 against Sunrisers Hyderabad -- and will look to extend his rich vein of form.

The likes of skipper Rajat Patidar and big-hitting Australian Tim David provide solidarity in the middle. However, it is RCB's bowling transformation that has stood out.

The Royals, meanwhile, have emerged as one of the most explosive batting units this season, powered by the opening pair of Jaiswal and teenage sensation Sooryavanshi.

The duo has consistently provided flying starts, combining clean hitting with fearless stroke-play to put opposition attacks under early pressure.

Women's Reservation Bill Stalin backs 33% quota, raises suspicion on poll-timed bill

CHENNAI: Chief Minister M K Stalin on Thursday alleged that the proposed amendment to ensure 33 per cent reservation for women in the midst of polls in states including Tamil Nadu appeared to be yet another political manoeuvre aimed at shaping electoral narratives. Stalin alleged the timing for the proposed amendment led to serious suspicion.

"Why push such a far-reaching decision in the middle of state elections. This appears to be yet another political manoeuvre aimed at shaping electoral narratives, much like earlier attempts to influence women voters ahead of the 2024 Parliament elections," he alleged in a statement titled "This is not reform, this is reengineering power." Further, he said: "Let me be unequivocal: we strongly support 33 per cent reservation for women. Our support is absolute. But it must be implemented without increasing seats and without punishing states that acted responsibly. If the intent is genuine, nothing prevents immediate implementation within the existing framework."

Demanding fair delimitation, he alleged there was complete opacity on the basis for delimitation and



asked would the exercise rely on 1971 figures from a pre-population control era or the 2021 Census. "Conflicting signals and vague assurances only deepen suspicion." This move would also impose a massive financial burden on states, forcing them to expand or rebuild Legislative Assemblies, all without proper consultation.

"This is a direct assault on cooperative federalism. This is not reform, it is a unilateral, politically driven exercise designed to concentrate power, weaken Parliament, marginalise the South, and undermine social justice," he alleged. "The nation deserves answers: why this undue haste, why shift the goalposts, and who truly stands to benefit?" The NDA government under Prime Minister Narendra Modi is systematically eroding the very foundations

of Parliament, he alleged.

The Dravidian party chief claimed: "What should be a vibrant forum for debate and accountability is being reduced to a hollow ritual, a stage where members may not even get fair time to speak or represent their people. This proposal to increase seats is a direct contradiction of their own slogan of minimum government, maximum governance. It will only inflate expenditure, burden taxpayers, and dilute the quality of parliamentary functioning."

This also went against the spirit of Article 1 of the Constitution, which defines India as a Union of States. Ignoring the voices of states and bypassing meaningful consultation is not democratic - it is unitary overreach that undermines the country's federal and plural character.

Kerala polling sees minor protests over bogus votes

THIRUVANANTHAPURAM: Assembly polling across Kerala progressed largely peacefully, but protests were reported at several booths on Thursday over allegations of bogus voting. A minor scuffle broke out between Congress and BJP activists at Manalur in Thrissur district after UDF candidate T N Prathapan arrived in the area.

According to police, BJP activists prevented people accompanying Prathapan from entering the booth premises, leading to the scuffle.

In Wadakkanchery, also in Thrissur district, a voter, Sajeew, was unable to cast his vote after election officials informed him that his vote had already been recorded as a postal ballot. This triggered protests by BJP activists, prompting police intervention.

Although election officials offered to allow him to cast a tender vote, he declined. BJP candidate T S Ullas Babu later arrived at the booth and staged a protest.

A similar incident occurred in Kuttiady, Kozhikode district, where a woman was denied the right to vote after it was found that her vote had already been cast as a postal ballot.

At Malampuzha and Shoranur in Palakkad district, Thrikkaripur in Kasaragod, and Vattiyorkavu in Thiruvananthapuram, complaints emerged that votes had been cast in the names of original voters, leading to protests.

The affected voters were later permitted to cast tender votes.

Bengal political row over Kabir video

KOLKATA

A political controversy erupted in West Bengal on Thursday after an alleged video of Humayun Kabir surfaced on social media, purportedly showing him claiming links with senior BJP leaders and efforts to defeat Chief Minister Mamata Banerjee in the upcoming Assembly elections.

At a press meet, the Tri-

namool Congress shared the purported video and demanded an Enforcement Directorate probe into Kabir's alleged claims of proximity with Leader of Opposition in West Bengal Assembly, Suvendu Adhikari, Assam chief minister Himanta Biswa Sarma and the Prime Minister's Office as part of a multi-core plan to defeat Banerjee in the polls.

In the video, which could

not be independently verified by PTI, Kabir is allegedly heard saying he is willing to go to "any extent" to unseat Banerjee and has been in touch with senior BJP leaders, including Adhikari.

Kabir termed the video as AI-generated and aimed at maligning him and threatened to take legal action. Kabir, who founded the Aam Janata Unnayan Party days after he was suspended by the

TMC late last year, is also purportedly heard claiming that he had communication with the PMO and was advised to coordinate with leaders from other BJP-ruled states.

The video further purportedly captures Kabir stating that his strategy revolves around diverting minority votes away from the ruling Trinamool Congress, suggesting that such a shift could benefit the BJP electorally.

'Op Sindoor demonstrated progression towards domain jointness'

BENGALURU: Army Chief General Upendra Dwivedi on Thursday said Operation Sindoor demonstrated India's progression towards "domain jointness" and called the military offensive carried out inside Pakistani territory a "defining case study" of operational significance of integration. In May last year, India had launched a military response targeting terror launchpads in Pakistan post the April 22 Pahalgam terror attack that killed 26 Indian tourists.

"Operation Sindoor was India's most powerful tool of progression towards domain jointness. But we need to achieve domain integration and fusion," General Dwivedi said. He was addressing the "Ran Samvad" forum on "Land Forces visualisation of Multi Domain Operation (MDO)," here. The army chief also highlighted the creation of an information warfare organisation and a psychological defence division following Operation Sindoor. He said, "15 per cent of our effort was on managing the disinformation campaign."

He cautioned, however, that key challenges remain, particularly in synchronising operations across strategic, operational and tactical levels and addressing the growing prevalence of hybrid or grey-zone warfare. "These are typically below the conventional military threshold, with the goal to exploit adversary vulnerability," he said, adding that non-kinetic operations are increasingly taking precedence.

NITK sacks former Registrar after probe confirms misconduct

MANGALURU: The National Institute of Technology Karnataka (NITK), Surathkal, has dismissed its former Registrar Ravindranath K. after a departmental inquiry established serious administrative misconduct.

The action follows his suspension on September 12, 2025, initiated at the direction of the Ministry of Education. The inquiry examined allegations of procedural irregularities and professional impropriety under the Central Civil Services (Conduct) Rules, 1964. Sources said the charges were found to be grave and were substantiated during the inquiry process, prompting the Board of Governors to unanimously approve the penalty of dismissal. Before the final action, Ravindranath's tenure as Registrar had already been terminated, as he was found to be holding the position beyond the five-year limit prescribed under the NITSER Act and institutional statutes.

In a statement, NITK emphasised that it maintains a strict zero-tolerance approach to misconduct. The institute said the decision reflects its commitment to transparency, accountability, and adherence to ethical standards in administration.

Formulate model SOPs for trekking safety: Minister Khandre

BENGALURU: Karnataka Minister for Forest, Ecology and Environment Eshwar Khandre has instructed authorities to formulate a standard operating procedure (SOP) for trekking safety, intended to serve as a national model. The Minister issued the instruction in writing to the chief wildlife warden in the wake of the disappearance of a woman from Kerala in the dense Tadiandamol forest, and the search for a minor girl in Chandradrona hills, his office said in a release on Thursday.

Like the 'e-Gastu' app already developed by the Forest Department and the 'MStripes' app used in tiger reserves, if a similar kind of app is temporarily installed on the mobile phones of trekkers during the trek, it will be easier to track those who go astray, hence the Forest Minister has directed to take steps to develop the app and provide group insurance to trekkers, it said.

Despite losing mother during exams, student tops state

In an extraordinary story of courage and determination, Disha, a student of Alva's College in Moodbidri, has emerged as the state topper in the Commerce stream of the Second PUC examinations—despite losing her mother in the mid-

War hits Belagavi farmers, cabbage crops destroyed

THE ongoing conflict in the Middle East has begun to impact farmers in Belagavi district, with vegetable growers facing severe losses due to a sudden collapse in demand. Farmers in villages such as Kadoli, Jafarwadi, Gondawadi, Belagundi, Handigund, Yellur and Uchgaon are now destroying their cabbage crops as traders refuse to purchase the produce.

According to farmers, the price of cabbage has plummeted drastically in recent weeks. While a 70-kg sack fetches barely ₹100 in the wholesale market, retail prices have dropped to just ₹1-₹2 per kg. This is a sharp fall from ₹40-₹50 per kg just three months ago. The decline reportedly began around two weeks after the escalation of war in the Middle East. The fall in demand has been attributed to



disruptions in the hospitality sector. Many hotels and small eateries have reduced or halted cooking activities due to LPG cylinder shortages, leading to a drop in vegetable consumption. Additionally, Belagavi-grown vegetables, which are usually despatched to states like Maharashtra, Goa, and Andhra Pradesh, are now witnessing poor demand from outside markets as well.

Frustrated by mounting losses, farmers have started

destroying standing crops using rotators or allowing cattle to graze on them. Farmer Appasaheb Desai expressed anguish over the situation, saying the emotional and financial distress has left cultivators devastated.

He pointed out that farmers invest months of hard work, only to see their produce go unsold. Another farmer, Mohan Kademani, said the cost of cultivation has become unbearable. "We spend nearly ₹45,000 to ₹50,000 per

acre, including saplings, fertilisers, labour and irrigation. For two acres, I expected returns of at least ₹2 lakh, but now traders are refusing to buy. We are forced to destroy the crop," he said, urging the government to announce compensation and minimum support prices for vegetables.

Officials from the Horticulture Department acknowledged the crisis. Joint Director Mahantesh Murgod said cabbage is grown extensively in the district, covering thousands of hectares across seasons. He noted that the war has disrupted demand, causing price crashes and distress among farmers.

He assured that officials will assess the situation on the ground and report to the government for necessary action. The crisis has once again highlighted the vulnerability of farmers to global events, with many now demanding urgent government intervention to prevent further losses.

Mentally unstable woman lives with husband's body for 10 days

IN a deeply disturbing incident from Chikkamagaluru district, a mentally unstable elderly woman reportedly lived with the decomposing body of her husband for nearly 10 days, unaware of his death. The incident came to light in Banakal village of Mudigere taluk, shocking the local community.

The deceased has been identified as 77-year-old Cyril Monis, who was living with his wife at their residence in Banakal. According to sources, he had been unwell for some time and passed away at home. However, his wife, who is said to be mentally unstable, did not realise that he had died and continued to stay with the body as it decomposed.

The couple's son works in Bengaluru, while their daughter is settled abroad. Both children were in regular contact with their mother over phone and would enquire about their father's health. Each time, the mother reportedly told them that



he was doing fine, leaving them with no suspicion initially.

As days passed, the son grew concerned after noticing inconsistencies in his mother's responses and the absence of his father's voice. He then asked a friend to visit the house and check on the situation.

When the friend arrived, he was confronted with a horrifying scene. Cyril Monis had died nearly 10 days earlier, and his body was in an advanced stage of decomposition. Despite this, his wife continued to remain inside the house with the body. Local residents, alerted by a foul smell, informed the police.

Social worker Arif, who assisted in the process, said that

when they reached the house along with police officials, the woman initially refused to open the gate. Upon entering, they found the body in a severely decomposed state.

"The body had decayed and was infested with maggots. With the help of police and locals, we shifted it and conducted the last rites at a Christian cemetery," Arif said.

The incident left residents shaken, as the children were unable to see their father one last time. Locals stepped forward to perform the funeral, displaying compassion and solidarity with the grieving family. A case has been registered at the Banakal Police Station, and further investigation is underway.

International gang behind rowdy sheeter's brutal murder, say police

MANGALURU police have cracked down on a cross-border conspiracy by arresting seven key players in the sensational murder of local rowdy sheeter Arif.

According to City Police Commissioner Sudheer Kumar Reddy, the arrested include Rifath, Juttu Ashfaq, Khalil, Shakir, Irfan, and Rizwan, who took part directly in the killing, along with Irshad who sheltered the accused and aided their activities.

The investigation has exposed that the entire operation was coordinated on an international scale. Two suspects, Mustafa and Ashwir, currently staying overseas, provided monetary support to help the culprits evade capture.

Another individual named Arshad not only supplied arms for the attack but also kept feeding the group details on police activities. Suhail arranged the rented car deployed during the crime



and escaped to Saudi Arabia right after the assault.

Officials suspect a much wider syndicate was involved in the conspiracy. Teams have spread a wide net to locate the other absconding accused, and the police commissioner assured that further arrests are expected shortly.

On the morning of March 27, Arif was heading to the Boloor fish market on his motorcycle when six of the accused tailed him in a car. They intentionally collided with his bike at the Takkottu flyover area.

The moment Arif was

thrown off, the attackers unleashed a ferocious assault using lethal weapons and escaped immediately. Old rivalry has emerged as the root cause of this meticulously planned execution.

To dodge police surveillance, the group relied on sophisticated technical methods. Ashwir from Dubai facilitated this by securing OTPs and enabling international WhatsApp numbers for the team. The accused maintained contact by constantly changing numbers, discarding one before investigators could trace it and shifting to another.

'Sudden rush on women's reservation driven by poll politics'**CONGRESS MINISTER ACCUSES CENTRE OF ELECTORAL MOTIVES**

MEDICAL Education Minister Dr. Sharanprakash Patil strongly condemned the Central government for its perceived hasty decision to implement women's reservation and undertake delimitation of Assembly and Lok Sabha constituencies, claiming it reflects political self-interest rather than public welfare.

Speaking at a press conference, the minister questioned why the Centre had remained silent on women's reservation for 15 long years and suddenly taken a cabinet decision now. He pointed out that if the policy had been introduced decades earlier, women would have greatly benefited. He asked who was responsible for the injustice done to women all these years.

Dr. Patil alleged that the proposal for women's reservation has surfaced only because of impending elections in five states. The issue should have

been discussed during the recently concluded Parliament session, where opposition views could have been considered. Instead, he said the Centre appears more interested in political gains than genuine women's empowerment.

He claimed that during the Bihar elections, the Centre had reduced GST rates and deposited money directly into people's accounts. He questioned where the taxes collected from citizens over decades had gone. In contrast, he noted that the Congress government in Karnataka faces notices even for implementing its five guarantee schemes. He further claimed that the Election Commission seems to dance to the tune of Prime Minister Modi and Amit Shah.

The minister also expressed suspicion over the delimitation exercise, saying increasing the number of constituencies based on the 1991 census appears to be a deliberate attempt to reduce the political strength of southern Indian states. He



suggested that if needed, delimitation should be done on the basis of the 1971 census and questioned the reason behind the current hurry.

On the controversy surrounding Congress president Mallikarjun Kharge's remarks, Dr. Patil clarified that Kharge had criticised the RSS ideology as venomous, not targeted any individual personally. He pointed out that BJP leaders have repeatedly used harsh terms like "Urban Naxals," "anti-nationals," "tukde tukde gang," and "looters of the nation" against Congress leaders, including Jawaharlal Nehru and Indira Gandhi. He asked

why criticism from the other side is considered acceptable while similar remarks from Congress are not.

He condemned the BJP for making light comments against Kharge and advised that any criticism of the senior Congress leader should be made with due responsibility and maturity.

Dr. Patil urged political parties to focus on development issues instead of mudslinging. He accused the BJP of never discussing development and instead specialising in raising sensitive matters for political gain.

The minister also highlighted positive steps in medical education. The government plans to start new government medical colleges in Bagalkot and Ramanagara, which will receive approval after inspection by the National Medical Council. He added that last year saw an increase of 400 medical seats, and this year another 450 seats are expected to be added.

Turning adverse circumstances into opportunities

Now earning Rs 1 lakh a month, she is not only financially independent but also creating employment opportunities in her village.

In the quiet village of Bandapalli in Wanaparthy district, 30-year-old Computer Science graduate Peddhabudi Vanaja is redefining what success looks like. At a time when

many chase conventional engineering jobs, Vanaja chose a different path—one that not only brought her financial independ-

ence but also created livelihoods for others in her community.

"Despite completing my Computer Science Engineering, I didn't want to sit and wait endlessly for a job. I wanted to build something on my own and create opportunities right here in my village," says Vanaja.

Her journey took a decisive turn through initiatives led by the Society for Elimination of Rural Poverty (SERP), under the guidance of Minister Danasari Anasuya and SERP CEO Divya Devarajan. In collaboration with the National Academy of Construction, the programme introduced women to non-conventional sectors like centring units and construction technologies.

"The training complete-

ly changed my perspective. I realised there is huge demand in construction and very few women are part of it. That gave me the confidence to step in," she explains.

The programme equipped her with technical knowledge—from materials like steel and aluminium to understanding design drawings and managing workflows—along with essential business skills.

"It wasn't just about learning a skill. We were trained on how to run a business—how to plan manpower, manage materials, and execute work properly," she adds.

With institutional support, Vanaja secured a Rs20 lakh loan under the Prime Minister's Employment Generation Programme, which enabled her to establish her enterprise. She aligned her business with the growing demand under the Indiramma Housing Scheme.

"Today, I operate three centring units in my village. Each unit supports

construction work, and there is steady demand because of the housing projects," she says.

Now earning close to Rs 1 lakh per month, Vanaja has not only achieved financial stability but also created jobs locally.

"This journey has changed my life. I am earning well, but more importantly, I am able to provide employment to others. People now see that women can succeed even in sectors like construction," she notes.

Vanaja is among 772 women trained under this initiative across the State. So far, 154 have established centring units, while 16 have applied for assistance under PMEGP, with Detailed Project Reports already sent to districts for further support.

"There are so many opportunities if we are willing to step out of our comfort zones. With the right training and support, women can achieve much more than they imagine," she says, summing up her journey.



Mamta Kulkarni says Indian women are not health conscious

THEIR LIVES REVOLVE AROUND THEIR HUSBANDS & CHILDREN

Actress Mamta Kulkarni has opened up about her perspective on how she feels that Indian families, especially the women in Indian families, do not take care of their health and are absolutely zero health conscious.

In a video shared by her on her own social media account, Mamta also said that the lives of most Indian women revolve around their families and taking care of their husbands and children, which is why they do not focus on their own health, stating that is absolutely wrong.

"I have noticed that some Indian families, especially women often do not focus on workouts. They dedicate their lives to their children and husbands, which sometimes leads to poor health. The same applies to men and children, they are often not very health conscious."

The actress also stated that she has seen even men and children in India coming to health clubs but just chit chat and do nothing about their health.

Further, she was seen expressing how important it is for each one to take care of their health.

Citing example of citizens of other countries, Mamta said that from kids to elders, everybody is very health conscious. From vitamin D to gymming, everybody takes care of their health, which is why they are so well built and fitter than Indians.

"Our body needs everything, including



vitamin D. People often laugh at foreigners wearing bikinis, but they don't realise how much vitamin D they are getting. That contributes to better growth and fitness. You will notice that many of them are taller and remain active even in their 80s, running in gyms and staying fit. Even small children are active, they swim, dive, and play."

She also cited her own example and said how she takes care of herself. "I now make it a point to spend time near the sea at least once or twice a week, usually on Saturdays, Sundays, or Mondays. This has been my process for many years, both physically and spiritually. Our body is made up of five elements: earth, water, fire, air, and sky."

She added, "I visit the beach once a week or once in two weeks. What do I do there? I walk barefoot on the sand. It is believed that walking barefoot on the beach can help cure many ailments. When I cannot go to the beach, I visit the health club instead. I go to the pool two to three times a week. I usually go around 2 pm, swim for an hour, and then spend at least another hour or two sunbathing."

She added, "I take sunbaths for two to three hours. I also swim, chat, and spend two to three hours here, sometimes from 1 pm to 5:30 or 6 pm. I also take steam and then, if possible, walk barefoot on the beach. When I was in Dubai, I used to walk barefoot on JBR beach. On Fridays or Saturdays, I would spend time there and walk on the sand for an hour under the sun."

Speaking about the benefits of walking bare feet on sand, Mamta said, "It is believed that the salt in the sand draws out impurities from the body. Some even say that people with paralysis can benefit from this practice if done consistently for a few months."

She concluded, "You should spend time in the sun and in nature to stay healthy. Breathe deeply as I am doing now and meditate. I often meditate while looking at the sun for hours. Come closer to nature, enjoy your food and life, but remember: if you are healthy, you are truly alive. You are your world. Jai Maa Bhavani."

professional commitments, Alaya will soon be a part of Hrithik Roshan-produced thriller series 'Storm'.

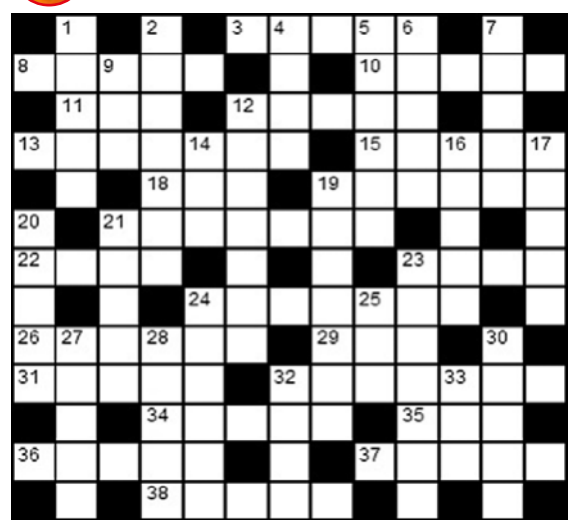

TCS Q4 net profit jumps to ₹13,718 cr

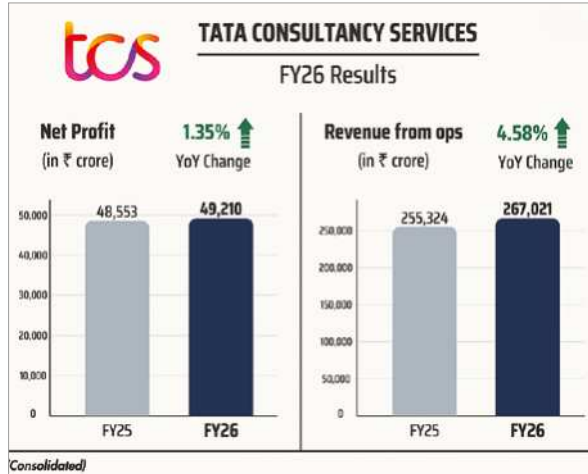

COUNTRY'S largest IT services company TCS on Thursday reported a net profit of Rs12,224 crore in the January-March period last year and Rs10,657 crore in the preceding December quarter.

The Tata Group company reported a net profit of Rs12,224 crore in the January-March period last year and Rs10,657 crore in the preceding December quarter.

For fiscal year 2025-26, TCS' PAT inched up 1.35 per cent to Rs49,210 crore, as against Rs48,553 crore in FY25. From a headcount perspective, the company added 2,356 jobs in Q4 to take the overall number of employees to 5,84,519 as on March 31, 2026, marking the first quarter of net addition after two consecutive quarters of a fall. The company's employee base declined by 23,460 in FY26, a year in which it began an exercise to cut 12,000 jobs because of changes in the technology landscape.

TCS is the first company in the \$315 billion Indian IT sector to report its earnings for



the fiscal year 2025-26, which saw a deepening of artificial intelligence (AI) technologies and subsequent concerns on the employee intensity in the sector which produces one of the best quality jobs in the economy.

In the reporting quarter, its revenue from operations jumped 9.64 per cent to Rs 70,698 crore from the Rs64,479 crore in the year-ago period, while the same for the full fiscal jumped 4.58 per cent to Rs 2.67 lakh crore.

The operating profit margin expanded to 25.3 per cent in the March quarter, up from 24.2 per cent in the year-ago period. Its chief executive and managing director K Krithivasan said this is the third consecutive quarter of sequential growth and added that the momentum was broad based across major markets and industries.

"While the macro-economic headwinds continue, we see sustained customer conviction in technology investments, which positions us well for the opportunities ahead," he said.

It signed new deals of \$12 billion in the three months, led by North America at \$5.4 billion and the banking, financial services and insurance business at \$2.8 billion.

The voluntary attrition stood at 13.7 per cent at the end of the quarter, and the company's chief human resources officer Sudeep Kunnal said it will be reverting to implementing salary hikes across the organisation from April 1 onwards.

Strong buffers to shield India from oil volatility: World Bank

Growth seen at 6.6% in FY27 despite Middle East-driven oil risks

THE World Bank on Thursday said India is well placed to weather the ongoing global energy shock, supported by strong macroeconomic buffers such as high foreign exchange reserves, fiscal space and low inflation.

Addressing a conference a day after raising India's GDP growth projection for FY27 to 6.6 per cent, World Bank officials said the country entered the current Middle East-driven oil market volatility from a position of strength. India had already demon-



strated resilience in the face of global trade turbulence in the previous fiscal. World Bank Regional Practice Director for South Asia, Sebastian Eckardt, highlighted that India's strong policy buffers and growth momentum provide room for policy support if required. He noted that structural reforms, including trade agreements and labour initiatives, are reinforcing the country's growth trajectory.

According to the World Bank's latest South Asia Economic Update, India's growth is estimated to have accelerated from 7.1 per cent in FY25 to 7.6 per cent in FY26, driven by robust domestic demand and resilient exports. Growth is projected to moderate to 6.6 per cent in FY27, slightly higher than earlier estimates.

World Bank Lead Econo-

mist for India, Aurelien Kruse, said India remained the fastest-growing large economy in FY26 despite facing high global tariffs. He credited income tax cuts and GST rate reductions for supporting consumption, while exports and investment performed better than expected.

The report described the current scenario as a "major trade shock" with risks tilted to the downside, particularly due to oil price volatility. The World Bank assumes crude oil prices at USD 90-100 per barrel for FY27.

It also commended the government's handling of the energy crisis, noting that authorities balanced supply management with price stability, avoiding extreme measures such as rationing while cushioning consumers from sharp price spikes.

Blue Star expects 20% volume growth this year

KOLKATA: Air-conditioning and commercial refrigeration major Blue Star Limited expects around 20 per cent growth in volumes and about 25 per cent revenue growth this year, its managing director B Thiagarajan said on Thursday.

He said the air-conditioning industry is currently facing a total cost impact of around 13 per cent, comprising 5 per cent from revised energy labelling norms and about 8 per cent due to higher raw material prices.

"Out of this, the industry has already passed on about 5-6 per cent to consumers, and another 5-7 per cent increase is expected in April to offset the remaining impact," Girish Hingorani, Vice President (Marketing - Unitary Cooling Products), said.

Thiagarajan added that margins, which typically stand at around 8.5 per cent for the business, have been squeezed recently due to cost pressures, with the company focused on pushing sales.

Silver, gold rally falters as West Asia tensions resurface

NEW DELHI: Silver prices declined by Rs 7,800 to Rs 2.43 lakh per kilogram in the national capital on Thursday while gold fell to Rs 1.54 lakh per 10 grams as investors booked profits amid concerns over the durability of the fragile ceasefire in West Asia. According to the All India Sarafa Association, the white metal depreciated by Rs 7,800, or 3.10 per cent, to Rs 2,43,200 per kg (inclusive of all taxes) from Wednesday's closing level of Rs 2,51,000 per kg.

Gold of 99.9 per cent purity also decreased by Rs 1,500, or nearly 1 per cent, to Rs 1,54,900 per 10 grams (inclusive of all taxes). The yellow metal had finished at Rs 1,56,400 per 10 grams in the previous market session. Analysts said precious metals witnessed selling pressure as uncertainty around the ceasefire between the US and Iran weighed on investors' sentiment. "Gold prices declined on Thursday, reversing most of the previous session's gains as investors reassessed the fragile ceasefire in West Asia," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

EQUITY benchmark indices ended lower on Thursday, with the Sensex tumbling 931 points after a spectacular rally in the previous session, as renewed tensions in West Asia faded the ceasefire-led optimism. The ceasefire deal appeared to be at risk after Iran closed the Strait of Hormuz again in response to Israeli attacks on Lebanon.

Weak trends in Asian and



European markets, a jump in crude oil prices and uninterrupted foreign fund outflows also made investors jittery in the domestic market. The 30-share BSE Sensex dropped 931.25 points or 1.20 per cent to settle at 76,631.65. During the day, it dived 1,215 points or 1.56 per cent to 76,347.90. The 50-share NSE Nifty declined 222.25 points or 0.93 per cent to end at 23,775.10. From the

30-Sensex firms, InterGlobe Aviation, Larsen & Toubro, Eternal, HDFC Bank, ICICI Bank and Kotak Mahindra Bank were among the major laggards. Bharat Electronics, Power Grid, NTPC and Tata Consultancy Services were among the gainers. Brent crude, the global oil benchmark, jumped 3.27 per cent to \$97.85 per barrel. "Ceasefire-led optimism faded as renewed US-Iran tensions and ongoing restric-

tions at the Strait of Hormuz pushed crude back up, reviving concerns around India's inflation. Domestically, profit-booking, rising 10-year bond yields, and rupee weakness reduced near-term risk appetite. Financials led the decline after the previous session's sharp rally amid sustained FII selling, while broader markets held relatively steady," Vinod Nair, Head of Research, Geojit Investments Limited, said. Foreign Institutional Investors (FIIs) offloaded equities worth Rs2,811.97 crore on Wednesday, according to exchange data.

Domestic Institutional Investors (DIIs), however, bought stocks worth Rs4,168.17 crore. US markets ended significantly higher on Wednesday. "Indian markets witnessed a pullback, snapping the recent five-session gaining streak as sentiment turned cautious amid fading confidence around the US-Iran ceasefire.

Morgan Stanley sees bull run in market, says will hit 95k mark

Earnings cycle revival, cheap valuations and strong domestic demand underpin bullish outlook

MUMBAI

GLOBAL brokerage firm Morgan Stanley on Thursday said that Indian markets are poised for a strong rally with Sensex likely to touch 95,000 level by December 2026.

In its latest India Equity Strategy Playbook report, the brokerage firm said that the current combination of depressed valuations, improving earnings momentum and cautious investor positioning reflects conditions typically seen near the end of market downturns.

In the base case, the headline index Sensex is expected to touch the 95,000 mark by December 2026, implying an upside potential of 22 per cent from Wednesday's closing, according to the brokerage. It noted that downside risks appear limited compared to potential gains, describing the present phase as an attractive entry point for long-term investors.

The brokerage also pointed out that India's trailing



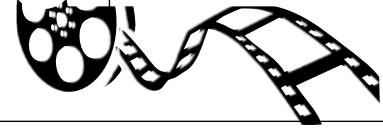
market performance over the past year is close to historic lows, while relative valuations have declined sharply.

However, underlying fundamentals remain strong, supported by robust domestic demand, policy stability and a recovery in capital expenditure. A major factor behind its bullish outlook is the revival in the earnings cycle. High-frequency indicators point to strengthening trends across consumption, investment and services, even as market expectations remain subdued, the brokerage noted.

Analysts also noted that India's share of global corpo-

rate profits now exceeds its index weight by the widest margin on record.

The brokerage has expected positive earnings revisions going forward and said it remains ahead of consensus estimates. Foreign investor positioning -- which has weakened in recent months -- could further support an upside surprise if earnings momentum continues to improve. On valuations, Morgan Stanley pointed out that the Sensex is currently trading at its cheapest level when measured against gold, a long-term indicator often associated with major market turning points.
