Farmers urged to avail crop insurance before July 31

DISTRICT Horticulture Officer Umadevi on Thursday urged all horticultural farmers in Anantapur district to enroll in the weather-based crop insurance scheme before the July 31 deadline.

Highlighting that dry chili falls under standard insurance, she stated that weather-based coverage applies to pomegranate, sweet lime, banana, and tomato. Per-acre premium rates are set at ₹3,750 for



pomegranate, ₹2,750 for sweet lime, ₹3,000 for banana, and ₹1,600 for tomato. With monsoon rainfall remaining deficit, DHO Umadevi emphasized

that adverse rainfall, temperature, or humidity levels will trigger insurance claims, making immediate enrollment crucial for farmers.



JNTUA secures 24th rank & gold rating in green university rankings 2026

ADONI: Throwing an open challenge to YSRCP president YS Jagan Mohan Reddy for a public debate on the Mega DSC recruitment process, HRD and IT Minister Nara Lokesh asserted that the recruitment was conducted with complete transparency.

Addressing a TDP workers' meeting in Adoni, Lokesh stated he was prepared to discuss the issue at any time and venue fixed by Jagan.

He questioned the YSRCP chief over seeking legal stays and court adjournments while demanding CBI inquiries.

Accusing the previous regime of stalling major projects like the Bhogapuram International Airport and driving away investment, Lokesh noted that Kurnool is now witnessing industrial revival through key projects such as Tata Solar and Drone City.

Recalling his Yuva Galam padayatra, Lokesh reaffirmed his commitment to establishing a High Court Bench in Kurnool,

APSPDCL moves to monthly settlement for rooftop solar bills

THE Andhra Pradesh Southern Power Distribution Company Limited (APSPDCL) has accelerated settlement of electricity bills for grid connected rooftop solar customers.

In a press release on Thursday, APSPDCL CMD Siva Sankar Lotheti said aligning with Central and State renewable energy initiatives, the company aims to provide faster, transparent services to solar consumers who feed surplus power into the grid. He said, surplus solar units, which were earlier settled quarterly, will now be billed and

settled monthly, based on import export meter readings and applicable regulations. He said APSPDCL reported that 36,963 customers across Nellore, Tirupati, Chittoor, Annamayya, Kadapa, Kurnool, Nandyal, Anantapur and Sri Sathya Sai districts have installed rooftop systems totaling 128 MW capacity. The company credited Rs 83.88 lakh to consumer bank accounts in June and Rs 68.4 lakh in July for the surplus generation. With rising household interest in rooftop solar, the CMD said it will continue improving billing, net metering and monthly settlement processes.

Public vigilance key to protect women, children from trafficking: DLSA chairperson

World Day Against Trafficking in Persons observed in Chittoor with an awareness programme

DISTRICT Legal Services Authority (DLSA) Chairperson and Senior Civil Judge MS Bharati said that creating awareness and encouraging vigilance among people are essential to prevent trafficking of women and children. She was speaking at an awareness programme held in Chittoor on Thursday to mark World Day Against Trafficking in Persons. The programme was jointly organised by District Legal Services Authority, ICDS and Police department.

The judge expressed concern that despite rapid technological progress, crimes such as human trafficking, sexual exploitation, bonded labour, child trafficking, forced begging, forced marriages and illegal organ trade continue to exist. She said that many women and children become victims due to a lack of awareness.

Public should be cautious of people, who collect money by offering fake jobs and those, who commit fraud through social media. Children, women, orphans and school dropouts are more vulnerable to such crimes. The judge urged

people to immediately inform the police if they notice suspicious persons or activities.

Bharati said that Bharatiya Nyaya Sanhita (BNS), Protection of Children from Sexual Offences (POCSO) Act and other laws provide strict punishment for offences related to human trafficking, child protection and sexual crimes.

ICDS Project Director Venkateswari said that if students are aware of such issues, they can help

protect their families and society. She urged everyone to remain alert about the safety of people around them and called for greater awareness to prevent serious crimes such as illegal organ trafficking. Women Police Station DSP Srinivasa Rao said, human trafficking is an organised crime. Traffickers first gain the trust of their victims before exploiting them. Young people travelling to other places for education or employment should not trust strangers easily, he advised.

Srisailam temple revises darshan & seva ticketing for Shravanam month

Srisailam Devasthanam announces revised ticketing rules and schedule modifications for the auspicious Shravanam month, spanning August 13 to September 12

To manage massive crowd footfalls, Arjitha Abhishekam and Arjitha Kumkumarchana will remain suspended on 19 peak days (all Fridays, Saturdays, Sundays, and Mondays)

On these 19 peak days, Sparsha Darshan will be restricted to a single 8:30 PM slot, capped at just 250 tickets. Regular three-slot operations will continue on non-peak days

ANTICIPATING a massive influx of lakhs of pilgrims from Andhra Pradesh, Telan-

gana, Karnataka, Maharashtra, and northern states, the Srisailam Devasthanam on Thursday announced revised schedules and online ticketing protocols for Sparsha Darshan

and Arjitha Sevas during the upcoming Shravanam month, observed from August 13 to September 12.

Releasing the new guidelines at a joint press conference on Thursday, Temple Trust Board Chairman Pothugunta Ramesh Naidu and Executive Officer M Srinivasa Rao stated that the adjustments aim to ensure smooth crowd management and hassle-free darshan for general pilgrims.

Under the revised plan, Arjitha Abhishekam and Arjitha Kumkumarchana will remain completely suspended on 19 designated peak days, encompassing all Fridays, Saturdays, Sundays, and Mondays throughout the Shravanam month.

On these high-footfall days, Sparsha Darshan will be restricted to a single late-evening slot at 8:30 PM,

capped at a limited quota of 250 tickets.

On all non-peak days, Sparsha Darshan will operate as usual across three slots—7:30 AM, 12:30 PM, and 9:00 PM—alongside regular Arjitha Seva ticket issuance.

To simplify procurement and eliminate middleman exploitation, the temple management has allocated 80 percent of all available tickets through the official 'Mana Mitra' WhatsApp platform, while the remaining 20 percent will be accessible via the Devasthanam's official web portal. The authorities advised visiting devotees planning to participate in Sparsha Darshan or Arjitha Sevas during the month-long festivities to secure their tickets well in advance through these digital channels before embarking on their pilgrimage to the shrine.
