

Draft voter list released for Anantapur district

Collector Anand says that claims and objections can be filed till August 30

DISTRICT Collector and District Election Officer O Anand has released draft voter list for Anantapur district on Friday at the Collectorate and handed over copies to Electoral Registration Officers.

The Collector said that the draft voter list was published as part of the Special Intensive Revision (SIR) programme, in accordance with the directives of Election Commission of India. He informed that the list shows 1,790,436 voters, including 8,83,174 men (49.33%), 9,07,053 women (50.66%), and 209 transgenders (0.01%). A total of 2,48,087 voters (12.17%)

were deleted under ASDD category—46,276 untraceable/absent, 79,582 permanently shifted, 75,378

deceased, 46,452 duplicates, and 399 others. The Collector said that claims and objections can

be filed from July 31 to August 30. Voters may verify the roll online or at the Collector's office, ERO/

AERO offices, or through their BLO between 10:30 am and 5 pm.

He explained the constituency totals as - Rayadurgam 2,36,579; Uravakonda 2,03,306; Guntakal 2,44,853; Tadipatri 2,19,095; Singanamala 2,22,458; Anantapur Urban 2,28,673; Kalyandurg 2,10,918; Raptadu 2,24,554.

There are also 2,021 service voters.

MLA assures justice to all during PGRS

PUTTAPARTHI MLA Palle Sindhura Reddy stated that the alliance government aims to swiftly resolve public grievances and ensure justice for people. Along with former Minister Dr Palle Raghunatha Reddy and RDO Suvarna, she received representations from people at a public grievance redressal system (PGRS) programme at the MLA camp office here on Friday. TDP activist Shyamala from Puttaparthi told the MLA that the then TDP government in 2014 had granted her a title deed for 2 cent house plot in Beedupalli village in 2014, sanctioned a permanent house for her and construction bill had been issued in her name. Stating that during previous YSRCP government's tenure, some individuals encroached her land, and she pleaded for justice, she sought justice. Responding immediately, MLA Sindhura assured her

The MLA assured them that she would facilitate a thorough investigation by the district Collector or higher officials into the corruption at the Dargah and ensure that the government takes appropriate legal action against the guilty. MLA Sindhura Reddy instructed officials to examine every petition received during public grievance programme with priority and to take measures ensuring justice for all eligible individuals.

APTIDCO housing refund beneficiaries to get money soon

A mega cheque model for refunds under APTIDCO-PMAY (U) NTR Nagar Housing Scheme was distributed at a programme at Anantapur Municipal Corporation premises on Friday.

A cheque model worth Rs 3,25,42,445 was handed over to 1,174 beneficiar-

ies under the Corporation's jurisdiction. Of the 5,707 eligible APTIDCO beneficiaries identified, the State government has released Rs. 8,91,40,000. So far, 1,964 have submitted the required details. The current distribution covers those, whose particulars were verified in Phase-I and Phase-II.

Commissioner Jaswanth Rao said the beneficiaries' details would be forwarded

to the banks, and the refund amounts would be credited directly to their accounts within one or two days after formalities. Another 707 cases are under re-verification, which is being expedited.

Eligible persons who paid under the scheme but have not yet received refunds or houses were urged to submit their documents at the Corporation office.

THE total number of voters in Tirupati district has come down to 14,81,603 in the draft electoral roll prepared under Special Intensive Revision (SIR)-2026, compared to 17,69,429 voters before the revision exercise. The draft electoral roll was released by Tirupati district Collector and District

Addressing the media at the Collectorate, the Collector said the revision was carried out as per the directions of Election Commission of India through a door-to-door verification drive. During the exercise, officials identified 2,87,826

cases involving absent voters, shifted voters, deceased voters and duplicate entries.

He said enumeration forms were submitted by 14,81,603 voters. Although mapping process is still pending for 1,62,230 voters, their names have been included in the draft electoral roll. Notices will be is-

sued to these voters between August 1 and August 30, giving them time to submit documents prescribed by Election Commission. Eligible voters, who produce required documents will continue in final electoral roll.

The Collector said the highest number of pending mapping cases were in Tirupati Assembly constituency with 96,280 cases, followed by Chandragiri with more than 50,000 cases. Sharing details of the identified cases, he said Tirupati Assembly constituency recorded 90,882 absent, shifted, deceased and duplicate cases, followed by Chandragiri with 50,273, Venktagiri with 36,497, Srikalahasti with 32,836, Sullurpeta with 27,946, Railway Koduru with 26,047 and Satyavedu with 23,345. These lists have been made available with Booth Level Officers (BLOs) for public verification.

The Collector said claims, objections, corrections, fresh voter registrations and deletion requests can be submitted until August 30. The final electoral roll will be published on October 3. According to draft electoral roll as on July 31, 2026, the district has 7,20,329 male voters, 7,61,188 female voters and 86 transgender voters and 2,221 polling stations. The draft electoral rolls are available with Electoral Registration Officers, Assistant Electoral Registration Officers, all polling stations and on Election Department website for public verification. Voters have been asked to verify their details and submit applications within the stipulated period if any corrections are required.

Joint Collector R Govindarao, DRO G Narasimulu and Election Department officials were present at the meeting.

Breastfeeding builds strong foundations for child health: Dr Bharath Reddy

BREASTFEEDING provides essential nutrition, infection protection and supports healthy growth, said paediatrician and neonatologist Dr G Bharath Reddy. Speaking ahead of World Breastfeeding Week (August 1-7), he stressed the need for greater awareness and support from families and society.

Dr Bharath said ideally, breastfeeding should begin within one hour of birth—whether normal or caesarean—unless medically contraindicated. Early skin-to-skin contact helps regulate baby's temperature and promotes successful feeding.

The World Health Organisation recommends exclusive breastfeeding for the first six months, with no water or other foods unless advised. He said that lactating mothers need proper

nutrition and fluids; unnecessary dietary restrictions are not required. Counseling should start in pregnancy and continue after birth, with trained lactation counsellors assisting when needed.

Workplaces should offer clean, private spaces for

breastfeeding or expressing milk. "Breastfeeding is not the mother's responsibility alone," Dr Reddy said. Family, healthcare professionals, employers and society must all create a supportive, breastfeeding-friendly environment so every child gets the best start in life.

Two Odisha migrant workers killed in accident

TWO migrant labourers from Odisha died after they were allegedly struck by a speeding car near Konduru village in Tada mandal of Tirupati district on Friday morning. The deceased have been identified as Arjun Bhatar (50) and Chaitu Gound (34).

Police said the two men had stepped out and were walking along the roadside when an unidentified vehicle rammed into them, leaving them critically injured.

Locals rushed to their aid and immediately alerted police. The injured workers

were shifted to Government Hospital in Sullurpeta in 108 ambulance for emergency treatment. However, doctors declared them dead despite efforts to save them.

Preliminary investigation suggests the accident occurred when the victims had gone out to attend nature's call. The vehicle involved in the incident fled the scene soon after the collision.

A case has been registered, and police have launched an investigation into the incident. Officials are examining available evidence to identify the offending vehicle and trace the driver responsible for the fatal hit-and-run.
